*A look at what the bills say... **In a Nut Shell***
Summaries from the OFFICE OF RESEARCH AND DRAFTING

A bill introduced in January of last year would create an enhanced homestead exemption for the surviving spouses of uniformed service members killed in the line of duty equal to all taxes imposed on the homestead. It was House Bill 22 and was referred to the House Ways and Means Committee.

In February the bill sponsors testified before the committee and in March a second hearing was held and the committee received testimony from Secretary of State, Frank LaRose, a Gold Star Spouse, and the great grandson of two Gold Star Mothers. All were in support of HB 22.

Four more hearings were held in March, April, and May with no witnesses at any of them. However two amendments were made to the bill during the May hearings.

During the first May hearing an amendment was made that would require a surviving spouse to have lived in Ohio for at least one year before receiving the bill's enhanced homestead exemption and limits the exemption to 10 tax years.

An amendment to allow a surviving spouse to maintain the exemption through the year of their death regardless of whether the surviving spouse remarries or cohabitates with an unrelated individual was made during the second May hearing.

Since the sixth hearing in May, House Bill 22 has not had any hearings.

House Bill 22-

The Detailed Analysis

As Introduced (before being amended)

Homestead exemption: gold star spouses

Continuing law provides a property tax credit for the residence, or "homestead," of certain qualifying individuals. The standard "homestead exemption" equals the taxes that would be charged on up to \$28,000, adjusted for inflation, of the true value of a home owned by a homeowner who is 65 years of age or older, permanently and totally disabled, or at least 59 years old and the surviving spouse of an

individual who previously received the exemption. ("True value" is the appraised fair market value.) This standard exemption is means-tested, so only homeowners with household income below a certain threshold (\$40,000 for tax year 2025) may qualify for the exemption. A special "enhanced" exemption of \$56,000, also adjusted for inflation, is available for the home of (1) an honorably discharged veteran of the armed forces with a total disability or the veteran's surviving spouse and (2) a surviving spouse of an emergency responder who died in the line of duty.

The bill creates an additional enhanced exemption for the surviving spouse of a uniformed service member killed in the line of duty equal to all of the current year's taxes assessed against the spouse's homestead. In essence, the enhanced exemption completely exempts such a surviving spouse's home from taxation. The exemption continues until the spouse dies, remarries, or cohabitates with another person that does not share a common ancestor with the surviving spouse ("consanguinity"). This is stricter than the enhanced exemptions for the surviving spouse of a disabled veteran or an emergency responder, which only terminate when the spouse either dies or remarries. The bill's exemption extends to members of the uniformed services, which includes the branches of the armed forces along with the National Oceanic and Atmospheric Administration and the Public Health Service. Like the other enhanced exemptions, the bill's exemption does not require the surviving spouse to earn below a certain income to qualify. The exemption does not apply to the surviving spouse of a dishonorably discharged uniformed service member. Similar to all other homestead exemptions, the bill's enhanced exemption applies to manufactured and mobile homes regardless of whether they are taxed as real property or subject to the manufactured home tax. Also similar to other homestead exemptions, the enhanced exemption does not exempt the homestead from special assessments.

WHAT OTHER STATES ARE DOING

There are many bills that will help veterans, military, or families of veteran or service member in just about, if not all the fifty states. Some of them are similar to bills we have in the Ohio General Assembly and some of them are unique to the states they are in. There are the 'Hey, why didn't I think of that' variety and some that might make you shake your head in bewilderment.

OLR takes a look at some of the Vet/Military bills in other states. They are bills introduced within the past year or so. They may still be in committees, have passed out of committee, or have been signed into law. You can look at the progress of each by going to the websites of each of the state's legislature. Maybe some of them will spark some interest and begin to grow in Ohio.



IN THE OREGON GENERAL ASSEMBLY

SB 150 The measure prohibits, except as applicable, compensation for preparing or advising on applications for veterans' benefits, appealing decisions on such claims, or for referring veterans to those providing these services.

SB 230 The measure requires dental care organizations and oral health providers contracting with the Oregon Health Authority to provide oral health care to veterans and to complete an intake screening with enrollees within 60 days of their contact with the organization or provider.

HB 3920 The measure modifies the Veterans' Dependent Tuition Waiver. It raises the age by which a dependent child can apply for the waiver from 23 to 31, removes the requirement that qualified students apply for a master's degree within 12 months of receiving a baccalaureate degree to receive a tuition

waiver for a master's degree, and allows an exemption to the age limit for anyone qualifying for the federal Survivors' and Dependents' Educational Assistance (DEA) program.

SB 807 The measure allows the Adjutant General to pay a bonus to members of the Oregon National Guard who reenlist or extend their period of service for at least three years and agree to any other conditions required by the Adjutant General. The bonus must be repaid if the member fails to complete the agreed-upon conditions or period of service; exceptions may be granted in specified circumstances.

SB 808 The measure adds current and former members of the Oregon National Guard to existing hiring preferences for veterans of the Armed Forces of the United States applying to, or seeking promotion in, civil service positions.

HB 3968 The measure adds the U.S. Space Force to Oregon statutes that name the other U.S. armed forces.



IN THE MICHIGAN GENERAL ASSEMBLY

SB 207 and SB 208 The bills would create a grant program administered by the Michigan Veterans Affairs Agency to help fund veterans service organizations that engage in veterans' service operations, such as assisting veterans in obtaining Federal Veterans Affairs health benefits. Veteran service organizations, such as the American Legion or the Veterans of Foreign Wars, serve with the purpose of connecting veterans and their dependents with benefits and services for which they are eligible.

SB 215 The bill would amend the Michigan Consumer Protection Act to do the following:

- Expand the definition of "veterans' benefit service" to include disability benefits.
- Allow only an individual accredited under applicable Federal laws and regulations to represent a veteran or a veteran's family as an agent or attorney.
- Require a person seeking compensation for providing veterans' benefit services for an initial claim for disability benefits to establish amounts to be paid in writing, receive only compensation contingent on an increase in awarded benefits, and protect a client veteran's personal and digital information, among other requirements

SB 703 The bill would designate the Honor and Remember flag as the official symbol of remembrance of the state of Michigan.

HB 5265 The bill would create a grant program to assist veterans in obtaining service animals; create certain funds; and provide for the powers and duties of certain state governmental entities.

HB 5266 The bill would create the office of veteran homelessness; provide for the identification, coordination, alignment, and acquisition of available resources and available programs for homeless veterans in this state; provide support and programs to secure housing for homeless veterans in this state or otherwise address veteran homelessness; provide for the powers and duties of certain state governmental officers and entities; and make appropriations and prescribe certain conditions for the appropriations.

HB 5269 The bill would require certain state and local governmental officers and entities to notify a county department of veterans' affairs or county board of commissioners of a report of abuse, neglect, or exploitation of a veteran; and provide for the powers and duties of certain state and local governmental officers and entities.

As with all current homestead exemptions, a surviving spouse must apply to the county auditor to qualify for the exemption. The applicant must include with this initial application a copy of the service member's U.S. Department of Defense form DD-1300 Report of Casualty or other federal documentation showing the service member was killed in the line of duty. After this initial application, no further application is needed to maintain the exemption, but the auditor must be notified if the homestead no longer qualifies for the bill's exemption.² (This notification is required under continuing law to report ineligibility for all current homestead exemptions.)

Reimbursement of local taxing units

As with all current homestead exemptions, local taxing units are reimbursed by the state for the reduction in property tax revenue that results from the bill's enhanced homestead exemption. The reimbursement is paid from the GRF semiannually or annually.

Application date

The enhanced homestead exemption for surviving spouses begins to apply for tax years ending after the bill's effective date or, in the case of homes that are subject to the manufactured home tax, tax years commencing after that date. The difference in application is accounted for by the fact that manufactured home tax is payable on a current-year basis, whereas property tax is payable in arrears.

SOUND OFF

Last month in Sound Off, OLR informed our readers about a published report ranking all fifty states on how veteran friendly they were. The report ranked Ohio in the 22nd spot.

OLR asked our readers to send us their suggestions for what Ohio needed to be more veteran friendly. The responses are given below.

All responses are listed. Our readers will see similar or duplicate items. There are possibly items that are already in the Ohio Revised Code or bills currently being worked on in the General Assembly. We listed them all so our readers will get a better understanding of what are the most important needs of our veterans.

Here are the suggestions we received.

From E.M. via email:

- Grant in-state tuition rates to qualified veterans and their dependents immediately upon establishing domicile, waiving the typical residency requirements.
- Accept and evaluate military experience and education for equivalent school credit to prevent redundant coursework.
- Designate "Purple Star" schools and universities that are supportive and inclusive of military-connected students and their families.
- Establish dedicated points of contact or veteran centers at educational institutions to serve as a resource hub for military students.
- Provide priority registration for veterans and service members at state colleges and universities.

Reflections

- Exclude military pension from income tax.
- Provide for military education as equivalent for civilian counterpart jobs. If you were a trained electrician in the Navy, you should be able to be a licensed electrician in the civilian world w/o the hassle.

- Facilitate professional license and certification transfers for military members and their spouses who are licensed in another state.
- Perhaps have add beds to the current Veterans homes. Or have smaller units/homes scattered across the state.

From a County Veterans Service Commission via email:

After conferring with my team, one of the largest suggestions they came up with is:
No state income taxes for all veterans who reside in Ohio to include military retirees and gray retired national guardsmen.
Personal property taxes reduced by percentage of disability to 100%= zero property tax.
2 more Veterans homes so all 4 corners of Ohio are covered.

From L.D. via email:

Its been awhile since I was looking up places to retire to, but it did stay with me that many states reduce the burden of retirement for veterans through various tax breaks.

The one veterans talked a lot about is no income tax. To me, those states just take bigger license plate taxes or sales taxes, so it winds up being a regressive tax.

A few had reduced property tax for veterans with any disability. That could encourage home ownership and stabilize neighborhoods. (You know how hard it is to get to 100% disability.) IF they want to get clever, they could target communities that need stability, like low-mod cities, to incentivize veterans as kind of a natural "community watch".

Free tuition for college, university, and trade school for Gold Star families

Create a dedicated fund to adequately support Ohio's 888 Suicide & Crisis Hotline

Recognize the Honor and Remember flag

Make it illegal for any firm or individual to file

VA claims for veterans unless they are VA accredited Service Officers

Mental health funding for the spouses of disabled veterans.

Property tax exemption for disabled veterans who are VA rated at 60% or higher

Double the number of beds available in Ohio Veterans Homes —either enlarge the ones we have or build new ones

From J.T. via telephone:

The biggest issue in our area is the lack of affordable housing. Rent is way too high for many veterans. Sellers do not want to sell to veterans using a VA home loan because the VA requires the seller to pay for all closing costs.

The other big problem is high property tax. Ohio should look at the neighboring states and at least match the state with the best property tax exemption for veterans. Neighboring states are much more veteran friendly.

From A.N. via email:

Upon reading the most veteran friendly states

article and seeing how Ohio was ranked 22nd when Ohio is one of the Top 10 Veteran populated states. I researched both the Education aspects of other states and property tax exemptions for other states. I feel if we, the State of Ohio can tackle these two key issues, we can begin to make Ohio one of the Top Veteran Friendly states.

Education For Veteran Dependents

Upon reviewing all the different states veteran and dependents education benefits, I think a combination of Maine and Nebraska's Dependents education benefits, and something like Missouri does for their Veterans would bring in Veterans to Ohio along with making it veteran friendly.

Maine: Tuition free, including mandatory fees and lab fees for Associates and Bachelors, room and board is not waived. Tuition waivers may be reduced by an amount necessary to ensure the value of waivers combined with other grants/benefits do not exceed the cost of education. Has 6 academic years to complete 8 semesters (may be waived for Medical Disability or Illness delaying education). Requirements: Veteran must have entered service through Maine or been a resident of Maine for 5 years preceding application, 100% Service Connected, KIA/MIA/POW, died from a service-connected condition. If the veteran dies and applicant applies 5 years after residency is established, it will be as if the veteran fulfilled the 5-year requirement.

Nebraska: Tuition waiver. Requirements: Resident of state, parent/stepparent/spouse member of the military. 1) Died from SC disability, 2) died subsequent to discharge from injury/illness from service, 3) 100% P/T disabled, 4) KIA/MIA/POW.

For Ohio (idea): Tuition free, including mandatory fees and lab fees for Associates and Bachelors, room and board is not waived. No waiver reduction but anything over the cost of education can be applied towards Room & board, dining, and books. Requirements: Veteran must have entered service through Ohio or been a resident of Ohio for 5 years preceding application, or 100% Service Connected, KIA/MIA/POW, or died from a service connected condition, or If the veteran dies and applicant applies 5 years after residency is established it will be as if the veteran fulfilled the 5 year requirement.

Education for Veterans

Missouri: Limits tuition to no more than \$50 per credit hour at all public colleges/Universities after other financial aid is taken into account, Associates

and Bachelors. Applies to Post 9/11 veterans only.

Ohio (idea): Limit the tuition to no more than \$75 per credit hour at a public College or University before GI Bill is paid or \$50 after all other financial aid is applied. Post 9/11 Veterans or veterans receiving VR&E.

Property Tax Exemptions

I am aware of the bill currently in the sitting at Legislation for veterans that are 100% P/T to receive full property tax exemption. But I feel there should be levels of exemption for every service-connected veteran. For example, your VA rate is the percentage of property tax, i.e., rate is 10%, 10% is taken from the property tax, 50% rate gets 50% removed from the property tax. There are also 10-30% rates, get \$25,000 removed from the property tax, 50-90% rate get \$50,000 removed from the property tax and 100% is full exemption.

These are just some of my ideas to help make Ohio more Veteran friendly.

My only suggestion on the State level is that all Ohio vet organizations could use is a complete list of

service members who have completed their tour of duty. Based on zip code, the group could reach out to that veteran in an effort for him to join their organization. I have been told that State doesn't have that info maybe true but if they could get it would help all the organizations grow which is what we need and more importantly show that vet perhaps unknown benefits.

From K.J. via email:

Continue to fund our Veterans Service Offices in Ohio and also our Schools. If property taxes are done away with we will have fewer veterans living in Ohio.

Let's work to provide more Veterans homes in Ohio. Sandusky and Georgetown are not enough.

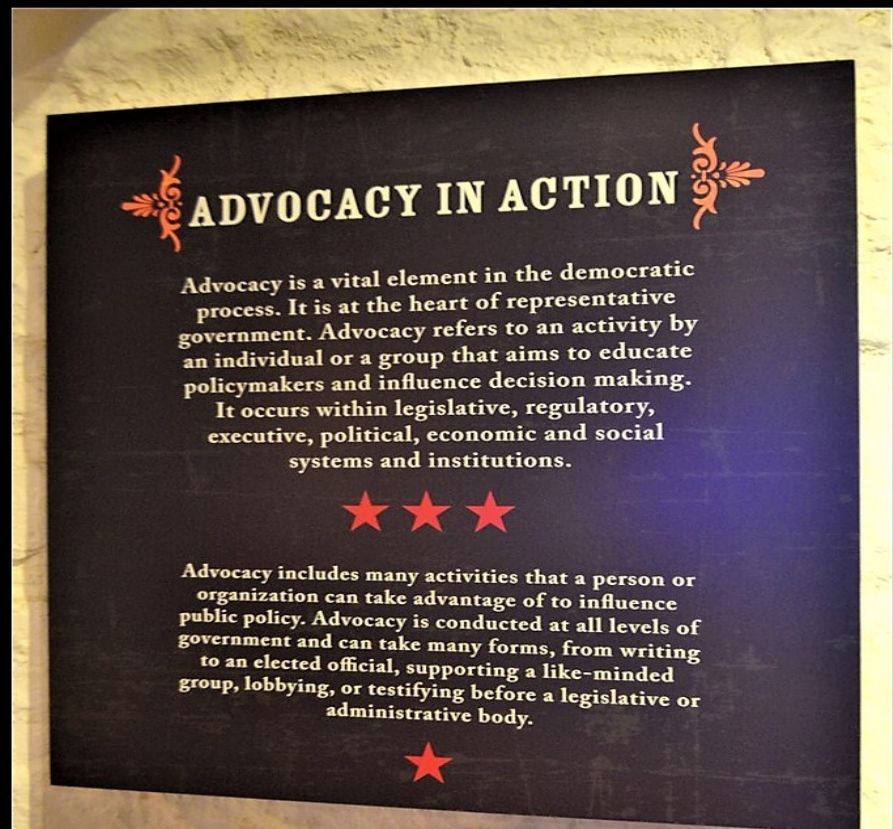
We must also find away to capture more Doctors, Nurses and more health care providers to work in Ohio.

LEGISLATION INTRODUCED IN DECEMBER

HB 632 was introduced on December 17 by Representative **Kevin Ritter** (HD-94).
