The 136th General Assembly held hearings in their committees for the first time since November 19. February, however, proved to be fairly busy, despite the House having one week of no hearings and the Senate not holding hearings in two different weeks. Nearly 20 pieces of veteran/military legislation had hearings in 14 committee meetings.

HB 720 and SB 372 were both introduced on the first working day in March. The two bills will be worked on in each house and then combined as one bill to be passed and signed by the governor, which he must do on or before June 30. The bills provide state funding for capital improvement throughout the state and are one-time grants. More in depth coverage of them will begin in the next issue of OL Report.

More legislation was introduced during the month of February than in all three previous months combined. Representatives dropped three bills and one resolution, while our Senators came up with four new bills and three resolutions during the month.

OL Report predicts each month will get a little busier than the previous because the legislators will be working hard to introduce and pass as many of their bills as possible before the end of this lame duck session.



### Hearings Held for Veteran/Military Legislation

#### February 2-6

Only the House held committee hearings this week –one on Tuesday and three on Wednesday. There were not any scheduled for the Senate.

The House Children and Human Services Committee met Tuesday morning for a hearing on HB 464. Testimony was given by bill sponsor Representative **Tracy M. Richardson** (HD-86). Her bill would amend Ohio's Revised Code to exempt family childcare providers certified by the U.S. armed forces from the law governing the regulation of childcare providers, including the requirement that certain family

A bill that would encourage Ohio companies to hire not only veterans and members of the military, but their spouses as well, was introduced last October and sent to the House Ways and Means Committee where it has only had one hearing.

The bill sponsors, Mark Sigrist (HD-10) and Jean Schmidt (HD-62) gave testimony on February 11. The bill is House Bill 529. When introduced it had eight representatives agreeing to be cosponsors.

The bill would do two things.

- One, it would authorize a refundable tax credit, claimable over up to five years, against several state taxes for an employer that hires certain veterans, service members, and their spouses and
- Two, it would compute the credit amount on a scale from \$100 up to \$750 per year depending on the disability and employment status of the qualifying employee.

**House Bill 529-**

**The Detailed Analysis**

*As Introduced*

**Tax credit for hiring veterans, service members, and spouses**

The bill authorizes a refundable tax credit, to be claimed over as many as five years, for employers that hire certain veterans, service members, and their spouses (referred to in the bill as “qualifying employees”). To obtain a credit, an employer must file an application with the Tax Commissioner by January 15 on the basis of a qualifying employee hired in the preceding year. The employer must include on the application the hiring date and, if applicable, termination date, the total hours the qualifying employee worked in the preceding year, and the tax against which the employer will claim the credit, which may include the insurance premiums, financial institutions, public utilities excise, petroleum activity, income, or commercial activity tax. The Tax Commissioner is required to evaluate applications in the order in which they are received, but may only issue initial determinations after the application window closes on January 15. An employer awarded a credit may claim it against the preceding year’s tax liability in the calendar year the credit is first awarded and in the following four years, so long as the employee remains employed at the

specified hours and the employer submits continuing applications. The bill requires the Tax Commissioner, by December 1 of each of those four following years, to provide continuing applications to each employer that was initially awarded a credit. These employers then have until December 31 to submit the application and reserve a continuing credit. The Commissioner evaluates the continuing applications to determine if employers are still entitled to the credit and issues new certificates before January 15, after which first-time credit awards begin to be distributed. The value of the credit is determined by whether the employee qualifies as a disabled veteran, the hours the employee worked for at least half of the preceding year, and whether it is the first or a subsequent year of the credit period. The following table lists the value of the credit in the first year and the up to four following years based on the classification of the subject employee in the preceding year:

<b>Employee classification in the preceding year</b>	<b>1st Yr.</b>	<b>Subsequent Yrs.</b>
Disabled Veteran: employed full time for 180 or more days	\$750	\$750
Disabled veteran: less than full time for 180 or more days	\$375	\$375
Other qualifying employees: full time for 180 or more days	\$500	\$200
Other qualifying employees: less than full time for 180 or more days	\$250	\$100

An employee may change classifications from year to year, including if an employee becomes a disabled veteran, and the credit amount can be increased or decreased accordingly in the remaining years of the credit period. If an employee is employed for fewer than 180 days of the year, the amounts described above are multiplied by the percentage of days out of the year the employee worked to arrive at the reduced credit value. The Tax Commissioner may not issue more than \$1 million in credits in each calendar year, with priority given to continuing applications.

**Application date and administrative rules**

A tax credit authorized by the bill may first be claimed for employees hired in the first year following the bill’s 90-day effective date. The bill requires the Tax Commissioner to adopt rules establishing what qualifies an employee as a veteran, disabled veteran, service member, or spouse of one of the former as well as what hours qualify an employee as full time. These rules are not subject to the requirements in continuing law governing agency review of rules to identify regulatory restrictions or the removal of two regulatory restrictions upon adoption of one regulatory restriction

## THE WORDS OF OUR LEGISLATORS

Some acts of courage are so profound that they echo across generations. One such act was carried out by a young man from Parma, Ohio named Frank A. Herda.

That is why I recently introduced House Bill 607, legislation to designate a portion of State Route 94 in Parma as the “Specialist Fourth Class Frank A. Herda, Medal of Honor Recipient, Memorial Highway.” I am proud that this effort is bipartisan, with my colleague, Representative Mike Dovilla of Berea, joining me as joint sponsor.

Frank Herda was more than a soldier—he was a son of Parma and an example of the very best our community has to offer. During the

Vietnam War, on June 29, 1968, Specialist Herda demonstrated extraordinary bravery under fire. When an enemy grenade landed among his fellow soldiers, he made a split-second decision that would save their lives. He threw himself onto the grenade, shielding his comrades from the blast.

That act of selflessness is difficult to comprehend. In a moment when most people would instinctively seek safety, Frank Herda chose to protect others instead. For this incredible courage and devotion to duty, he was awarded the Medal of Honor, our nation’s highest military award.

Frank passed away in 2023, but his legacy continues to inspire those who learn about his life and sacrifice.

Designating a portion of State Route 94 in his name will not change the past, nor can it fully capture the depth of his heroism. But it will ensure that the people who drive that road every day—residents,

Currently the 2 Veterans homes are over 3 hours from the Northeast and Southeast portions of Ohio. childcare homes be licensed by the Department of Children and Youth. She introduced her bill last September.

Wednesday morning HB 500, sponsored by Representatives **Ty D. Mathews** (HD-83) and **Kevin Ritter** (HD-94), had its third hearing. There was no testimony submitted but Ritter motioned for an amendment that would allow National Defense Cadet Corps (NDCC) program to be included in the bill with the Junior Reserve Officer Training Corps (JROTC) program as part of the district's career-technical education (CTE) program. The amendment also requires the Department of Education and Workforce to include in the calculation of a school

district's CTE funding any JROTC or NDCC program a district designates as part of its CTE program. The amendment was accepted without objection. The two Representatives introduced the bill in October.

Two bills were on the agenda in the Veterans and Military Development Committee that morning –House Bill 292 for a 3rd hearing and House Bill 452 for its first.

HB 292 was introduced last year in May by

Representatives Ty Mathews and **Nick Santucci** (HD-64) establishes the Defense Industry Expansion Program under which the Ohio Defense Commission may make grants to support economic development related to the defense industry. It also establishes the Ohio Defense Fund and specifies allocation requirements for money in the fund. Any revenue from interest earned on bonds of the State of Israel, in the state treasury, be deposited into the Ohio Defense Fund. There were two present to give testimony supporting the bill and ten other proponents who submitted written testimony.

Two members of the committee were next to give sponsor testimony for HB 452, a bill they introduced in September that would designate October 1st every year as "761st Tank Battalion Day" in Ohio. Committee members **Cecil Thomas** (HD-25) and **Meredith R. Lawson-Rowe** (HD-5), who is Ranking Member of the committee testified that the 761st Tank Battalion was a tank battalion of the U.S. Army during World War II whose ranks

February 12, 2026

Beginning this year, March 9th will be recognized in Ohio as 6888th Central Postal Directory Battalion Day.

Governor Mike DeWine signed into law Senate Bill 17, recognizing the 6888th Central Postal Directory Battalion — the only unit composed of women of color to serve overseas during World War II.

He was joined by Judith and Stanley Earley, the children of LTC Charity Adams, the battalion's commanding officer and highest-ranking Black female officer in the U.S. Army during WWII.

The bill sponsors, Senators **Michele Reynolds** (SD-3) and **Hearcel F. Craig** (SD-15) stand on either side of DeWine.



February 17, 2026

Amidst a large turn out for the quarterly Veterans Legislative Caucus, Representative **Bernard Willis** (HD-74) announced that he was stepping down as chairman of the caucus due to new commitments recently added to his already full plate.

Taking over the reigns will be Representative **Michael D. DoVilla** (HD-17). DoVilla served as a representative in the 136th Ohio General Assembly and has a lengthy history with the US Navy Reserve currently holding the rank of Commander.

primarily consisted of African American soldiers. The Battalion first saw action in Northern France in October 1944.

The final bill to have a hearing on Wednesday was House Bill 22 that would amend the Revised Code to authorize a full homestead exemption for surviving spouses of members of the uniformed services killed in the line of duty.

Representatives **Brian Lorenz** (HD-60) and **David Thomas** (HD-65) introduced their bill a year ago January and since then it has had six hearings as well as being amended twice (see June 2025 issue). In this hearing the bill was once again amended, and it became Substitute Bill 22. This amendment was made by bill sponsor, Thomas, and reduced the exemption for the spouse of a fallen military service member for a full

exemption to an enhanced exemption of \$59,300 per year. Testimony was heard from Carl Price Legislative Chair for the Ohio Military Order of the Purple Heart. His testimony was the only one given.

**February 9-13**

There were no committee hearings on Tuesday, but on Wednesday there were two in the Senate while the House had one.

Senate Bill 302 was the first bill to have a hearing, and it was before the Senate Transportation Committee. It was the second hearing for the bill sponsored at the end of October by Senator **Terry Johnson** (SD-14) The bill would create the "Land of U.S. Grant" license plate which could be purchased for any passenger car, noncommercial motor vehicle, recreational vehicle, or other vehicle. In addition to the \$10 additional administrative BMV fee, a \$20 contribution would be paid by the applicant. The contributions would be paid to the Land of U.S. Grant to further the organization's mission. Testimony was heard from the a witness who spoke on behalf of the organization, Land of U.S. Grant as well as five other organization which authorize him to express their support of the Bill. Written testimony was also submitted by the president of the General Sherman Civil War Roundtable.

In the Senate Armed Services, Veterans affairs and Public Safety Committee, SB 218 sponsored by Senator **Kristina D. Roegner** (SD-27) had a third hearing. The first to give testimony was the Manager of Engagement, Dayton Development Coalition, followed by Great Lakes Regional Liaison at the Defense-State Liaison Office, operating under the direction of Under Secretary of War for Personnel and Readiness. Both voiced strong support for the bill that exempts family childcare providers certified by the U.S. armed forces from the law governing the regulation of childcare

providers, including the requirement that certain family childcare homes be licensed by the Department of Children and Youth in order to operate.

The one House committee was the Ways & Means Committee that had scheduled the first hearing for HB 529. Sponsor testimony was given by Representative **Mark Sigrist** (HD-10) and written testimony was provided from Representative **Jean Schmidt** (HD-62). The bill would allow for a refundable tax credit, against several state taxes for an employer that hires certain veterans, service members, and their spouses. A more detailed explanation of the bill can be found in the column, *In a Nut Shell* on page two. It was introduced in October of last year.

**February 16-20**

The House was busy this week. There were two committees meeting on Tuesday and two on Wednesday, while the Senate only had one and it was on Wednesday.

Tuesday morning the Children and Human Services Committee met and held a second hearing for Representative Richardson’s HB 464. Testimony was heard from the Manager of Engagement, Dayton Development Coalition while the Senior Director of Policy Groundwork Ohio provided the members with written testimony. Both witnesses were supporters of the bill.

That same afternoon the 4th hearing for House Bill 500 was held in the House Education Committee. Representative Ritter made a motion to favorably pass the bill out of committee and recommend its passage The motion passed with a vote of 12 to 0.

At 9:00 in the morning the next day, the House Natural Resources Committee met and held the second hearing for Amended Senate Bill 223. Am SB 223 is the bill of Senator **Thomas F. Patton** (SD-24) that would establish a discount program for all veterans and service members who present, in a manner determined by the chief, a valid form of documentation. The discount program shall provide a twenty-five per cent discount for all park services and rentals. It had passed in the Senate with a vote of 33 to 0 last October. Patton gave sponsor testimony in the House Committee in November. Proponent testimony was given in person by David K. Root, State Legislative Chairman of the Department of Ohio VFW and written testimony by Cynthia Boehnlein, Legislative Chairman, American Legion Auxiliary Unit 2.

Later the same morning, members of the House Veterans and Military Development Committee had three bills on their agenda. HB 576 was first. Jacob Brault, Legislative Coordinator for the American Legion Department of Ohio had submitted written proponent testimony and Retired Master Sergeant Greg White gave his proponent testimony in person. White is a 30 plus year veteran of the Ohio Air National Guard and the Air Force Reserve. HB 756 would designate November each year as

Veterans’ Month to encourage the observance of events recognizing the contributions of Ohio veterans. The bill was sponsored by Representative **Riordan T. McClain** (HD-87) during the first week of November.

The second bill to have a hearing was HB 292. Representative Mathews, the bill sponsor and Vice Chair of the Committee made a motion to amend his bill making it a substitute bill. The sub bill would make several amendments to the original bill. It would change the composition of the Commission and provide a number of other items

for the purpose of adding additional transparency and accountability. The name of the commission would also change because of the addition of the aerospace industry. The new name would be the Ohio Defense and Space Commission. The motion was agreed to and the sub bill was accepted. Two written testimonies had been submitted by proponents of the bill.

The third bill on the agenda was SB 244 which would designate August 26th as "Abbey Gate Remembrance Day." The bill was sponsored by Senators Roegner and **Jane M. Timken** (SD-29) in August and passed in the Senate 33-0 on November 5. Before testimony began, Representative **Haraz N. Ghanbari** (HD -75) moved to amend the bill. The bill which would commemorate U.S. service members who lost their lives

in the attack at the Abbey Gate of Hamid Karzai International Airport in Kabul, Afghanistan, on August 26, 2021. lists the name, city, and state of each of the 13 KIAs. The amendment would add the branch of service for each of them. There were no objections so the motion to amend was agreed to. The committee members then heard testimony from United States Navy veteran, Joe Burdick. It was Burdick who brought the issue to Roegner and asked her to sponsor it.

Only one bill was scheduled for a hearing in the Senate Armed Services, Veterans Affairs and Public Safety Committee. It was Senator Roegner's bill, SB 218 and there was no oral testimony given nor any

written testimony received by the committee.

**February 23-27**

The House held hearings for three bills in two committees –one on Tuesday and one on Wednesday. The Senate did not schedule any hearings this week. It was a light week for the legislators after a heavy schedule the previous week.

The Tuesday Committee hearing was for HB 464 in the Children and Human Services Committee. It was the third hearing for the bill and there were no witnesses of any kind.

The next day members of the Veterans and Military Development Committee had two bills to consider for a possible vote. Neither HB 297 nor SB 244 had any witnesses testifying so Vice Chair Mathews motioned to favorably pass HB 297 out of committee. After the members voted, he motioned to do the same thing for SB 244, and again the members voted. For each motion the members voted 12 to 0 in favor.

**In The Month of March**

You can expect both houses to be busy with their Capital Appropriation Bills. There will be many lengthy hearings and lobbyists and advocates wanting a few minutes of office time to push their cause.

## LEGISLATION INTRODUCED IN FEBRUARY

**SB 346** was introduced on February 2 by Senator **Terry Johnson** (SD-24).

The bill would amend sections 4501.21 and 5910.07 and to enact section 4503.4913 of the Revised Code to create the "1905 Wright Flyer III" license plate.

It was referred to the Senate Transportation Committee.

**SB 351** was introduced on February 4 by Senator **Nathan H. Manning** (SD-13).

The bill would amend section 121.221 of the Revised Code to allow an active duty service member on deployment, and who is a member of a public body in the state, to attend meetings of the public body virtually.

It was referred to the Senate General Government Committee.

**HB 681** was introduced on February 4 by Representative **Marilyn John** (HB-76).

The bill would enact section 5534.654 of the Revised Code to designate a portion of State Route 13 in Richland County as the "Marine PFC Glenn S. Wingenbach, Jr. Memorial Highway."

It was referred to the House Transportation Committee.

**SB 356** was introduced on February 10 by Senator **Kyle Koehler** (SD-10).

The bill would temporarily increase the amount of the homestead exemptions and to declare an emergency.

It was referred to the Senate Finance Committee.

**SB 362** was introduced on February 10 by Senator **Bill Reineke** (SD-26).

The bill would amend section 121.22 and to enact sections 113.052, 122.952, 122.953, and 122.954 of the Revised Code to establish the Ohio Defense and Space Commission.

It was referred to the Senate Workforce Development Committee.

**HB 708** was introduced on February 4 by Representative **Bernard Willis** (HB-74).

The bill would amend section 1345.032 and to enact section 5901.10 of the Revised Code to govern the practice of providing veterans claim consulting assistance for compensation and to establish requirements for soliciting a fee for providing a copy of a military discharge record.

It was referred to the House Veterans and Military Development Committee.

**HB 721** was introduced on February 4 by Representatives **Lauren McNally** (HB-58) and **Meredith R. Lawson-Rowe** (HD-5).

The bill would enact section 122.381 of the Revised Code to establish the Veterans Organization Grant Program and to make an appropriation.

A bill is a document by which a member of the General Assembly proposes to enact a new law or amend or repeal an existing law. The term "bill" is used to refer to the document from the time it is drafted and delivered to the members until it is considered and approved by both the House and the Senate. After passing both houses, a bill becomes an "act" and must be presented to the Governor for acceptance or rejection. If accepted, or if the Governor does not take any action for ten days, it becomes a "law."

The details of every bill can be found on the Ohio Legislature website. You can also check the status of bills as they travel thorough committees and sessions, find out how the voting went, and read the testimony of every witness.

To find a bill type the bill number (example: SB 712 or HB 943) into the search bar.
