

A&G WINNERS TOUR WASHINGTON AND GETTYSBURG

Eighteen State Winners in the 2016-2017 Americanism and Government Test program, accompanied by chaperones from the Ohio American Legion and Ohio American Legion Auxiliary, under the direction of Tour Director; Department Americanism Director Gerald White, toured Washington D.C. and Gettysburg, Pennsylvania, March 6-11.

The March A&G trip was the culmination of the Department's Americanism and Government Test program for 2016-2017 and continues an annual event conducted by the Ohio American Legion every year since 1936.

Highlights of the trip included special tours of the Kennedy Center for the Performing Arts; the Washington Cathedral, viewing the United States Constitution and Declaration of independence at the National Archives, visiting all of the major memorials in Washington D.C., having the group hosted at dinners by Gettysburg American Legion Post #202, and Bedford PA American Legion Post #113, and touring the Gettysburg national battlefield.



A special opportunity afforded the group was traveling to Marine Corps Base, Quantico, Virginia to be briefed by officers of Marine Helicopter Squadron One which flies the President of the United States aboard the "Marine One" helicopter, members of the White House staff, and distinguished visitors to the United States.

While at Marine Helicopter Squadron One, the Americanism and Government group got "up close and personal" with a Marine MV-22 Osprey flown by the Squadron and one of the Executive "white top" helicopters that flies the President.

Chaperones representing the American Legion and American Legion Auxiliary were Department First Vice Commander Stanley Pleasant and Auxiliary First Vice President Shirley Maurer.

DO NOT: submit more than two to three sentences. Space is very limited and a lengthy submission must be cut down to meet space requirements. While I am a proud Legionnaire, I hate having to cut these down as I may inadvertently leave out information you would rather have included over something else in your submission.

DO: submit ONE photo of the

DO NOT: submit more than one photo per event. DO: provide your write-ups in legible handwriting or typed if pos-

DO NOT: scribble a write-up and expect me to decipher.


DO: take the time to send in photos and articles.

Submitting an article and picture from another publication can cause myself, and the Legion, to face plagiarism lawsuits that come with very hefty fines.

DO: mail submissions to "Attn: Ohio Legion News, 60 Big Run Rd, Delaware, OH, 43015" or email them to legion@ohiolegion.com with the subject line: Ohio Legion News submission.

DO NOT: send in random photos or emails with no reason as to why I am receiving them and expect me to guess as to why. We also have photo contests for the new Legion Calendar and I don't want to mistake one for the other.

The number you are allowed to choose is limited by the size of your Post as designated on the Department Delegate Chart. For instance, a post with a membership of 217 gets 3 delegates. So while anyone can attend the convention, and we do want to get all of our members to the convention, only the delegates are allowed to vote.

All of the convention information is included in the Convention Call packet sent to your Commander and Adjutant this past month. In that packet are forms which must be sent to Department detailing your committee representatives, delegates, and alternates. Your delegates can be

committee reps and mittee reps do not have to be delegates. When your delegates get to Dayton they must register with Department personnel by 11am on the Saturday of the convention or they will not be counted as official and your Post

loses a vote. The check-in needs to be by 11am on Saturday so the delegates have time to caucus (a meeting of delegates) and discuss the various issues which will come on the floor for a vote. We normally caucus by District.

The purpose of the caucus is to give the delegates the chance to hear the committee reports, discuss the issues at hand, and determine how they want to vote on the issues.

CAUTION: while all of the delegates may vote the same way on an issue, no delegate is bound to

the decision of a caucus. Each delegate votes his or her own conscience unless specific direction is given by the Post on how to vote each is-

Who can be a Delegate? Any member in good standing (defined as current dues are paid) can be a delegate. Some posts have stated in their by-laws who can be delegates and typically those are current and past officers of the Post. Many Posts give the right of first choice to the current Commander and the new Commander and fill in with other interested members. The main reason for this is to be sure the Post gets delegates who understand the issues and the working of a convention; experience is a big benefit. Whoever is nominated for delegate and alternate, the body must vote to

confirm the delegates

Delegate Duties. Commit to make the committee meetings and especially the District caucus. Ask questions, weigh the issues, and vote for the good of the legion. Voting at convention is where the Blue Caps lead the way!!!

DEPARTMENT EXECUTIVE COMMITTEE

HIGHLIGHTS

The Department Executive Committee meeting held April 1st was blessed to have in attendance the leading candidate for National Commander Denise Rohan from the Department of Wisconsin. Candidate Rohan graced the DEC with a touching story of an eight-year-old child she had met on the campaign trail at an event whose father has been deployed so many times during his childhood that this boy does not miss him when he is gone because the child has experienced more life without him. She used this story to tell of the need of The American Legion. A need greater now than it has ever been.

A resolution was presented by District 11 naming 1st Vice David Jackson, who passed away during his 1st Vice year, as an Honorary Department Commander of the Department of Ohio. A worthy tribute for a person who dedicated so much to this organization.

Adjutant Simons provided an after-action review of the Mid-Winter Conference, introduced the new Department Bookkeeper Dan Hessler, and spoke on the progress of PDC Campbell's Commander Project.

Department 1st Vice Pleasant then briefed the DEC on the successes and failures of this year's Past Department Commander Round-Up and the Department's falling short of the Commander's membership goal. He presented several resolutions with regards to the membership program. All resolutions were passed. These resolutions made the Department DMS Committee a sub-committee to the Membership Committee, Medal of Honor recipient Chief Edward Byers of Grand Rapids is having his PUFL membership paid for by Department, and two resolutions calling for changes to the National Constitution and By-Laws regarding eligibility requirements were approved and will be forwarded to National Headquarters for review at the National Convention in Reno. These two resolutions call for expansion of the eligibility dates for the Panama/Grenada Era of eligibility and also the Persian Gulf Era.

A policy change was also presented by 1st Vice Pleasant from the membership Committee requiring the Consolidated Post Reports to be turned in as opposed to the old, unused, unpaid, and blank membership cards. The DEC approved.

A restructured Awards Manual for 2018 was presented and approved (see Mission: Possible for details).

2nd Vice Schmitt then spoke on his attendance at the Department tournaments and activities. He also spoke on the Centennial Committee that he has been named as chairperson and presented a resolution to create said committee. The Centennial Committee will last until November 11, 2019 and will oversee the Department 100 year celebrations of The American Legion.

Parliamentarian Minadeo then addressed the DEC concerning Post quorums and the need to have quorums high enough to allow for members outside of the Post Executive Boards to object to decisions being made as failure to have these quorums opens opportunity for fraud and abuse.

The consolidation of Post 289 into Post 322 was approved.

Past Department Commander Bishop then provided a detailed and in-depth report concerning the Gifts for the Yanks program highlighting the creation of a sub-committee designed to approve of the gifts that are given to those veterans in the homes.

Mary Austin, Chairperson of the Employment Committee then gave a report over the "Boots to Business" event that was hosted at Department Headquarters and put on by the Small Business Administration.

Legislative Chairperson Malcolm Glasgow then gave a report concerning Ohio House Bill 49 and the proposal to change how the funds allocated to the Veteran Service Organizations are divided. He also spoke on the Department Legislative Committee's stance on the "Drug Price Relief Act," which calls for Medicare and Medicaid to receive the same pricing allocated to the VA. A resolution was presented calling for the Department of Ohio to publicly and strongly oppose the "Drug Price Relief Act." Resolution passed.

There was no other official business to come before the committee.

My name is Michael and I was in the Air-Force. I am an OEF/OIF veteran. That is all I wish to be known about my service or career. That is not what is important here, what is important is the sick feeling in my stomach. I would hope that most everyone listening to this statement has at least a fraction of concernment for helping our nation's military during times of peace and war. As well as when they return and struggle to survive in the civilian world. Vietnam veterans, does this sound familiar?

I will never judge anyone's pain as less than my own and I will never doubt that my experiences were easier or harder than anyone else's. We can only go based on facts when it comes to the bureaucratic efforts to support our nation's veterans. I will not educate you on these facts because that's not my place. The number of veterans who are homeless, sick or just having a bad day, cannot get the care they are entitled to and fought for and in some cases died for is staggering.

In November of 2016, I was having a bad day. I had lost all hope because the organizations I was seeking help from (VA, blah blah) could not provide any assistance. A food pantry got me through day to day on basics like

milk and bread. I was ashamed but it was what I had to do to survive. I almost killed myself multiple times. My fiancé was 6 months pregnant. I had no money, no food, no car, nowhere to turn. I returned to the VA one last time because I was in crisis mode, I sought immediate intervention because I just could not continue. Little did I know this visit would change my life, not because of the VA, but because of who was visiting that day. A very professional, polite lady from the American Legion approached me. Now, being 28 years old, I had the stereotype that the American Legion was full of WW2 veterans and members of whom I had nothing to give to, because that has been my purpose in life, to serve others. I was in tears, she welcomed me home and started friendly conversation and made me feel very comfortable. She did not know me nor did I know her. She was in the middle of a guided tour with VA representatives and members of the American Legion in Ohio. I didn't feel any less important than them. I expected her to say keep your head up and carry on with her business. Instead, she insisted they continue without her and wanted to hear my story. At this point I was calmed down enough

to communicate. After working for several hours with her that day, I left her office with hope. I left her office looking forward to my baby coming and being successful in life.

I was ready to die and because Suzette Price had the resources, timing and genuine passion and care in her heart to directly fight the impact that is affecting our veterans every day, I got to live. I am a success story now in more aspects than one in my life. I got to feel what it is like to be my families hero again. I could go into finances and business success I have been empowered to do because of this, but you should hear that from me directly. I wouldn't mind an invite next time you want to hear my story.

You don't cut military spending by not giving our troops on the front-line ammo. Don't do it to our troops fighting our civilian front lines helping our veterans. These problems that the American Legion is directly combating for our veterans will only get more abundant and more complex as time goes, to cut their resources is downright unconstitutional. How much is my life worth?

VETERANS SHOULD SUPPORT AN ARTICLE V CONVENTION OF STATES

Congress has shown an unwillingness to face the looming debt crisis by limiting spending. When they have their backs to the wall and must start cutting they will ask for the active military, retirees and all veterans to do their part first. I know this because the American legion was founded 100 years ago in response to the neglect of the federal government to meet its obligations to the returning troops with the excuse that there were now greater concerns for the good of the country and the veterans should be willing to pitch in - the nerve. It continues today with the watering down of the retirement package and most recently they floated an idea to charge Veterans using their education benefits a \$100 per month fee. Now the American Legion is millions strong and we cannot let this neglect ever happen again. The Article V Convention of States Project is just the big solution for the even bigger problem.

If the Congress is unable or unwilling to arrest the out of control spending, limit their reach into the business of the states, and to leave office after a reasonable period to allow for new ideas and fresh representation of the people, then the states and the people need to take back their liberty – peacefully – through the amendment process.

The Constitution gives the states the ability to check the business of Congress. As a matter of fact it is the states that are the fourth branch of government in the balance of power – a fact we used to learn in civics class. So how do the states use this balancing power?

Our founding fathers provided in the Constitution under Article V two ways to amend the Constitution. The first and most prominently known way is for twothirds of both houses to propose and three-fourths of the states must ratify. This has been used twenty-seven times with the first ten amendments being the Bill of Rights in 1791 and the twentyseventh (addressing Senators and Representatives compensation) being ratified in 1972. The second option is for "an Application of the Legislatures of two-thirds of the several states" to the Congress, to call a Convention for proposing amendments. Those proposals would then go to the state for a three-fourths ratification. This option has never been used but tried many times only failing to meet the high bar of two-thirds of the states agreeing on the application

This "states" amendment option was placed into Article V at the last minute as a check on a federal government that would simply get

so large as to override the liberties of the states and the people. It was not a matter of "would" the federal overreach happen, but rather "when" it would happen. The founders understood the nature of governments to grow out of control as our government today with the looming debt, state budgets that are 80% mandated by the feds, and elected officials, judges, and appointed bureaucrats being allowed to stay in office much longer than necessary.

The time to act is now. The Ohio Congress is considering joining ten other states to ratify the application for an Article V Convention of States to impose fiscal restraint on the federal government, limit the power and jurisdiction of the federal government, and limit the terms of office for its officials and Members of Congress of the Unites States.

Your mission, if you so choose to accept, is to 1) go to https://www.conventionofstates.com, sign the petition, and volunteer, then 2) call your state Senator and Representative to tell them to vote for the Senate Joint Resolution 1 (SJR1) and House Joint Resolution 2 (HJR2) an Article V Convention of States.

CHAPLAIN'S CORNER

Legion Family,

The other day I was at a birth-day party luncheon when a 50-year member of The American Legion, close friend and one of my mentors, Irv Marshall made a statement that started me thinking. He said: "The trouble with the Legion today is, the new members today don't know and many of the older members either forgot or don't give a ----that the American Legion is 'For God and Country."

Even though we recite the "Preamble" at most official Legion meetings, proudly declaring the first four words, how many of us have thought about them and why those founding, WWI veterans decided to begin the Preamble of our Constitution with that very direct and meaningful phrase. Maybe it was because in that day, the vast majority of the U.S. population was raised to believe a person's priorities in life should be: God, Family, Country, in that order.

Remember, the first caucus was comprised of members of the American Expeditionary Force, meeting in Paris only four months after the Armistice had been signed. Most of these men were battle tested veterans who had witnessed the horrors and cruelty that one human being could inflict upon another.

Not only had their physical and mental stamina been tested and pushed to the limit, so had their faith. They say: "There are no atheists in a foxhole." I have never been under fire in a foxhole, so I cannot attest to whether or not this is true. However, I have spent time with young soldiers who have been under fire in the equivalent of a foxhole in Iraq or Afghanistan. After their experiences, they have actually questioned why a loving God would allow such brutality and

without a rock-solid faith in God, based on the foundation of regular prayer and worship, I can understand why they could question His presence.

Prayer and Worship are two practices strongly encouraged by The American Legion. Enumerated in National's "God and Country Programs" are "Attend Church Regularly" and "Daily Family Prayer." These are programs, that if not communicated to the members, go without practice or awareness thereof.

Without a foundation based on knowledge, our members have no understanding of what our organization actually stands for or does. They don't know about the "Four Pillars" upon which this organization was founded or all the charitable work the Legion Family does. Our members remain ignorant of the REAL American Legion.

I would encourage Posts to always perform the "Initiation Program," found in the Officer's Manual and provide informational/instructional material for all new members.

It is also critical that each Post have an active Public Relations Chairman. The American Legion will not survive without recruitment and retention. We can no longer accomplish the preceding based on the presumptions of the past. To remain the number one advocate and voice of the veteran, we must inform veterans and the community at large, of our good work and the programs in which our Posts are involved.

Let us remind every member and inform our communities that it is: "For God and Country we associate ourselves."





We Oppose the Deceptive Drug Purchase Ballot Issue In Ohio

- We oppose the ballot issue that will appear before Ohio voters in November 2017, which would prohibit the state from entering into contracts to purchase prescription drugs unless the prices are the same or lower than the special discounts provided to the U.S. Department of Veterans Affairs (VA) and our nation's veterans.
- This flawed and unworkable proposal could actually increase prescription drug costs and reduce prescription drug availability for veterans, all while costing taxpayers millions more in state bureaucracy, red tape and lawsuits.

On 1 April 2017, The Department of Ohio Executive Committee passed Resolution No. 17-09, Ohio Drug Price Relief Act, which stated the following in the resolve clause:

n November 2017, Ohioans will be asked to vote on a flawed, deceptive ballot issue that could raise prescription drug prices and limit access to needed medications for military veterans. It's bad for veterans and bad for taxpayers. Veterans' organizations should oppose it.

Under federal law, the U.S. Department of Veterans Affairs (VA) receives discounted pricing on prescription medication from drug manufacturers. The ballot issue, put forth by a controversial California activist, proposes a new law that calls for the state of Ohio to pay no more for prescription medications than the lowest price paid by the VA. The proposed law would apply to programs that serve public retirees and state workers, Medicaid beneficiaries, injured workers, prisoners, patients in state university hospitals, and others. It does not apply to the majority of Ohioans with private health coverage.

Experts have concluded this proposal is unworkable and cannot be implemented. An almost identical version of the proposal appeared on the November 2016 California ballot as Proposition 61, and was defeated. More than 30 veterans groups in California were among 200 opposing organizations, including doctors, business, labor and patient groups. Every major newspaper opposed Prop. 61.

Impossible to Implement

The VA is not required to disclose how much it pays for medications. That means state entities would not know what benchmark to meet. But if Ohio voters approve the ballot issue, state officials would be *legally required* to implement the new law, forcing them to challenge the VA for information and taking up resources both the state and the VA could put to better use.

How much the VA pays for any particular drug is a moving target. In addition to specified percentage discounts, the VA frequently gets additional rebates from drug manufacturers, credit for volume purchases and other deals. These change periodically and are not disclosed by either the VA or the manufacturers.

The VA Says the Misleading Rx Proposal Will Raise Costs for Veterans

The VA itself said in a 2016 issue briefing that these additional discounts are likely to be eliminated by pharmaceutical manufacturers if VA pricing is extended to other entities like state governments. The briefing estimates an increase in VA prescription drug costs of \$3.8 billion a year, if the proposal is voted into state law.

The US General Accountability Office (GAO) has on several occasions examined the issue of extending VA discounts to

other programs and warned that a mandatory extension could undermine the VA's ability to obtain favorable pricing for drugs and the limit the availability of some medications to the VA. In 2000, the GAO advised against including Medicare in the VA's pricing structure for this reason.

Military Families are Already Paying More

Already, veterans in Ohio and across the country are seeing rising costs. As part of the 2016 National Defense Authorization Act, Congress voted to increase co-pays that military retirees and dependents of active duty military pay out of pocket by 25%. If the ballot measure passes and VA and DOD drug costs go up, we can expect added pressure to increase prescription drug co-pays that veterans, military retirees and dependents of active duty military have to pay out of pocket. That would affect more than 866,000 veterans, active duty military, and military retirees residing in Ohio, plus 21 million veterans nationwide who have served our country.

Alternatively, the VA and DOD could deal with higher drug costs by deciding to omit certain drugs from their formularies - limiting veterans, military personnel, and retiree access to needed medications.


There's No Benefit for Ohio Taxpayers


Medicaid and other state entities already use percentage discounts and rebates when purchasing medication. Should voters approve the ballot proposal, these existing contracts would cease, with unknown costs and complications for Ohio taxpayers. The administrative costs of trying to implement an unworkable law would fall on Ohio programs that serve vulnerable populations such as people who are developmentally disabled, people with mental illness, newborn infants, injured workers, the elderly and other Ohioans.

The VA's Program is Designed for Veterans

The Veterans Healthcare Act enables the VA to provide medical care including prescription medications to our nation's military veterans in recognition of their service. The discounts mandated in the Act were never intended to be extended to states. The program is also designed to meet the needs of the military population and the drugs included reflect that.

As we prepare to close out another year it is important to reflect upon the past 12 months. The 2016-2017 year proved to be a whirlwind year complete with many changes, the full effects of which may take a couple years to fully feel. As the saying goes, the only constant in life is change.

This past year saw a rejuvenated Membership Committee. A committee that normally met once a year to approve of the next year's Award manual, met almost monthly using video conferencing, allowing the members to stay home in their pj's while also making decisions and saving time and money. These meetings allowed for a quicker reaction time to needed policy changes and/or actions requiring immediate attention. This is a huge advancement and provides a good stepping stone for a trajectory into the future.

A few important changes for the 2018 year are needed to be known by each Post within our borders. The first and most important is the change in policy regarding the return of your unused, unpaid, and blank membership cards. This policy has been discontinued. It is now the Post's responsibility to properly destroy the membership cards.

Department's recommendation is to include these cards before or after your Post's flag retirement ceremony. If your Post does not have such a ceremony, another Post near you very well may. The card requirement has been replaced with the already mandatory but never enforced turn-in of the Consolidated Post Report. If you are unaware of this report, then that is exactly why the policy has been changed. Every year the Department Commander briefs the National Commander on the percentage of Posts who have completed this form. Ohio has traditionally ranked low. This form has a due date to Department Headquarters of July 1st, so by the time you receive this newsletter, you should still have roughly one month to complete and return, complete on your Post's mylegion account, or contact us to receive the form if you have not received it thus far. The Certification of Post Officers is still required to be turned in as this form tells us where the 2018 cards are to be sent. Both forms can be completed online eliminating the need to pay your local postal worker and saving your Post money.

The past few years each Post should have been hearing Department preach and yell about myLegion.org and the importance and usefulness. Well, it just became a whole lot better. Posts now have the option to renew their members

online, transfer members online, and even sign up new members, without mailing anything to Dept. hq. Why is this important? The posts that use this feature will have significantly less members questioning why they received renewal notices after having paid, the Posts will save money in postage, and their membership numbers will be accurate within 24 hours, not weeks or months. Needless to say, but just in case we should, it is Department's recommendation that EVERY Post finally sign up for a myLegion. org account, although it is not required. 361 out of our 544 Posts in Ohio already have an account


with 80% signing in every couple of weeks. We thank you and we think you will find the new features of great use.

2018 will also bring a revamped Awards Manual which moves away from Departments rewarding only the District levels for accomplishments in membership. You will see in the manual that most award funds are now designated to go to the Posts and frontloaded, rewarding the Posts that meet their targets fastest. Below is a timetable of the awards. Gone are the traditional lap dates of every month. We want your Post sending cards in (paying on myLegion) as quickly as possible so that the members who have already paid their dues do not receive renewal notices.

We feel confident that once the initial shock of change passes, each Post, and all their members, will see how these changes will positively affect the membership program and/or the posts financial positions. Unfortunately, the Post Office may not be able to say the same.

Of course, at any time, if you have questions regarding the new membership policies, or even the old ones, I am always available.

Change, it will make our mission possible.

Who We Are and Who We Were

Biographical Sketch of National Commander John R. McQuigg

From enlisted man to brigadier general, from farm boy to president of his own bank, from buck private in The American Legion to its national commander - such is the record of "Go Gettum" John Rea McQuigg whom the Omaha convention unanimously elected to lead the Legion for 1925-1926.

Commander McQuigg has been serving the organization in important capacities since its inception seven years ago. He was the first commander of Engineers Post of Cleveland; delegate to the first department convention in 1919; delegate to the first national convention and brought the 1920 convention to Cleveland. Then he was promoted to department commander of Ohio in 1920, a delegate to the second national convention and at this time was appointed a member of the national finance committee in which capacity he has served the organization ever since.

In the Legion's two most important issues – adjusted compensation and the endowment drive for disabled veterans and war orphans, he toured the county making outstanding speeches. Meantime, he has served on the Ohio department committees, national convention committees and in 1923 was vice-chairman of the Legion's national legislative committee.

In his military record, he has also delivered unusual service. In 1888 he was graduated from Wooster University as cadet captain, and shortly thereafter joined the famous Cleveland Grays, a private military unit. In 1898 when war with Spain was begun, the Grays became a part of the National Guard as an engineer unit and successively McQuigg was a first lieutenant, captain and finally major.

In 1912 he was commissioned a lieutenant colonal of the 112th Engineers (the old Cleveland Grays outfit) and went to the Mexican border

In 1917 shortly after war was declared he was commissioned a full colonel of the 112th Engineers and made up his mind to go to training camp with a full-recruited unit. He pitched camp in the heart of Cleveland and began an intensive recruiting campaign. So successful was hes effort that when the Engineers moved to Camp Sheridan, Alabama, every company was at full war strength and Colonel McQuigg took a dozen extra men along in case of emergency.

It was at this time that he became known as "Go' Gettum" McQuigg, a title heard universally throughout Ohio.

Somebody said, when he was placed in command of the 112th Engineers, "How are you going to recruit so many men in such a short time?"

McQuigg replied; "Well, I guess I'll have to go get them."

Then he pitched his camp and did just that.

In May, 1918, the regiment moved to Camp Lee and in July sailed for Brest. Led by Colonel McQuigg, the engineers saw active service in the Baccarat sector, in the Argonne and in Belgium.

Recommissioned a colonel of Engineers in 1920, McQuigg was appointed brigadier General of Infantry in 1921 and federally recognized.

Commander McQuigg is fiftynine years old and a farm boy who grabbed his education where he could get it.

The only romance of his life began in a little red district school house to which he rode six miles each day on horseback. The now Mrs. McQuigg, then a red-cheeked girl, sat opposite the heavily-built farm boy. Wanting to make her acquaintance, McQuigg hit upon the expedient of borrowing her ruler, then her eraser, then her pencil and whispering to her, The tactics while brave nearly ruined Imgard which was her name, was afraid the teacher would see Mc-Quigg's friendly efforts; and sat on him hard.

Due to the fact that his services were needed on the farm, Mc-Quigg lost a term every spring and always made it up by studying at home. He tells the following story:

"Just about that time," McQuigg said in his precise English, "sulky plows were coming into use. My father bought one. As you know, about all you have to do on a sulky plow is keep the hoses straight and turn at the end of the row. So I used to copy off my Greek and Latin vocabularies and my trigonometry problems and study them riding that sulky plow. In that way, though I was out a term each year, I never got set back."

After graduation from Wooster College, McQuigg went to Cornell University for one year to study law and then to the National Law School at Washington. He was graduated and admitted to the Ohio bar(?) and settled in Cleveland.

He was elected Mayor of East Cleveland in 1907 and reelected twice. He organized and developed the Windermere Savings and Loan Company (a three million dollar banking corporation) and is still its president.
