We can officially say the Winter is over, and that Spring is here, "April showers bring May flowers," and the way it has been raining this April, we should have lots of May flowers. Hopefully, we will have more Spring-like weather and not go right into hot Summer weather. With all of this being said, let's get started on the business of the Legion.

At this writing, I only have two months left as your Commander, and by the time you read this, it will be about 30 days left. The Department of Ohio receives \$9.00 out of each member's DUES, and we have approximately 100,000 members bringing our income to \$900,000.00. This \$900,000.00 is used to support our veteran service offices in Cincinnati, Dayton, Chillicothe, Columbus, and Cleaveland. These offices help our veterans file their VA Claims and Appeals (one of our Four Pillars VA & R). It also helps with American Legion Buckeye Boys State program, and American Legion Baseball to name a

few of our Children and Youth Programs (another one of our Four Pillars). The Americanism and Government Test and Trip to Washington D.C. fall under Americanism, and that is our Third Pillar. So you can see how important your membership is in The American Legion.

Your Membership is also very important when we go to Washington D.C. and talk with our Senators and Representatives about veteran issues especially the VA Healthcare System. I have had the opportunity to attend the Washington Conference for the last three years, and this year I had the opportunity to watch our National Commander testify before the Joint House and Senate VA subcommittee. I assure you that your membership in The American Legion is critical to our strength and power with Congress. So, Please consider paying your DUES as soon as possible, we need every one of you.

For you, members that are a member of our Post #888, every one of you is welcome to go to any Post for their activities. You might find a local Post were you feel comfortable. Just because you are in Post #888 doesn't mean that you cannot go to any event or activity at any Post. Please check out the local Posts near you. Check the Department website for upcoming events. The State Convention will be in Toledo June 28, 29, and 30, 2019 you are welcome to come. You never know who you may meet

The State Convention is in Toledo this year, June 28, 29, and 30, 2019 and everyone is invited. However, you will not have a vote unless you are a Delegate for your Post. We do charge a minimum fee of \$5 to register as a guest or Delegate. Come and have some fun and comradery with fellow veterans and members. We are working on making this Convention even better than last year's.

I also would like to mention the importance of our "Buddy Check" initiative. The "Buddy Check" is something that we have done in the past, but never had a name for it. It is important that you reach out to fellow members, especially if you haven't heard from them in an extended amount of time. For all, we know these members could be deceased, in hospice, or a nursing home, and their relatives are no longer paying their dues. Reach out to the members of your Post and ensure their wellbeing. En-

sure that they are getting the help that they need and that their membership is up to date. Make them know how important they are to the Post.

If you are a Paid Up for Life member, please ensure that your address and contact information is up to date with our National Headquarters. Some of you may have noticed that you haven't received any information in the mail from National in quite some time. That is because your address is marked as undeliverable, which will result in National marking you as deceased and canceling your PUFL membership. Please take the initiative to contact them with your most updated address information if you have not received any information from them this past membership year. What have we passed on? What have we received from others that we have forgotten? Again, our slogan this year is "Celebrating

Our Legacy". The following story was told to me when I was stationed at Fort Ord in California in the 1990's. There was a Navy Fighter Pilot, who after 75 combat missions in Vietnam, was shot down by a surface-to-air missile. He ejected a parachuted into enemy hands, was captured, and spent the next six years in a communist prison camp. He survived, and has lectured on the lessons he learned while a prisoner.

One day, as he and his wife were sitting in a restaurant, a man at another table came over and said to him, "You flew Fighter jets in Vietnam from the aircraft carrier, Kitty Hawk. You were shot down!"

"How in the world did you know that," replied the Pilot. "I was a Sailor on the Kitty Hawk, I packed your parachute." The Pilot gasped in surprise and gratitude. The Sailor shook his hand and said, "I guess it worked!" The Pilot answer, "It sure did, if your chute hadn't opened, I wouldn't be here today! It saved my life."

That night, the Pilot couldn't sleep, thinking about that Sailor. He kept thinking about what he looked like in a Navy Uniform: a white hat, a bib in the back, and bell-bottom trousers. He wondered how many times he might have seen him on the ship and not even said "Good Morning, or How are you" because you see, He was a Fighter Pilot and the man was just a Sailor." The Pilot thought of the many hours the Sailor had spent at a long wooden table in the bowels of the ship, carefully weaving the shrouds, and folding the silks, of each chute, holding in his hands each time, the fate of someone he didn't know.

After this event, the Officer always asks those who come to hear him speak, "Who's packing your parachute? Everyone has someone who provides what they need to make it through their day." The Pilot mentioned that he needed many kinds of parachutes when his plane was shot down over enemy territory - he needed his physical parachute, his emotional parachute, and his spiritual parachute. He used all these supports before reaching safety.

Sometimes in the daily challenges that life gives us, we miss what is really important. We may fail to say hello, please, give a compliment, or just do something nice for those who've packed our parachutes.

As you go through this week, this month, or this year, are you leaving a legacy for those supports in your life?

Are there limits on the amount of expenditures that can be made without prior approval of the post executive committee or the membership? If your post is operating a clubroom or charitable gaming are the accounts for those operations receiving the same scrutiny

and reporting rules as the post operating funds? Does the ALR chapter and SAL Squadron make a monthly financial report to the Post and is the post finance officer a signatory on any accounts maintained by those organizations? They should also be using the posts federal EIN on their accounts and their receipts and expenditures included in the annual Form 990 filed by the post. I suggest that every post review its financial management policy and procedures on a regular basis to ensure that the post remains healthy in this important area.

I would like to remind everyone that your year books for your post or District has to judging no later than July 27, 2019. We would like to see more year books this year.

101st Department Convention Constitution and By-Law Resolutions

Legionnaires at every membership level are afforded the opportunity to suggest changes in their local posts' policies, or even to the way the Legion operates as an organization. Legionnaires interested in initiating such a process must file a resolution - a written description of a problem or situation, followed by a suggestion as to how it may be corrected. A resolution may also be a statement or declaration pertaining to an issue of concern to the Legion. It consists of two parts: the preamble (description of the problem), and the resolve clause (how the local post, department or national organization should solve the problem or support the issue). The entire resolution should be one continuous sentence, with the preamble clause(s) preceding the resolve clause(s).

Resolutions are often submitted by a Post, County, or District to the Department Executive Committee or to the General Assembly by a Post, County, or District.

All proposed amendments to the Department Constitution and/or By-Laws must be received in Department Headquarters at 60 Big Run Road, Delaware, Ohio 43015 by May 29th, 2019.

All resolutions, other than those proposing to amend the Department Constitution and/or By-Laws must be received in Department Headquarters by June 18th, 2019.

Subject: Oroposed increase to department of Ohio membership



RESOLVED, By the American Legion in Department of Ohio Convention assembled in Toledo, Ohio, June 28-30, 2019, That the Constitution of The American Legion Department of Ohio, Article XII, Section 2 which reads:

The amount of such annual Department dues beginning January 1, 2004, shall be nine dollars (\$9.00) per member, of which each year at least one dollar and twenty cents (\$1.20) shall be allocated to publish and mail to the entire membership a Department newspaper; at least fifteen cents (\$0.15) shall be allocated for Department Convention operations; and at least thirty cents (\$0.30) shall be allocated to aid Delegates to the National Convention. (Amended 85th Department Convention 2003)

That the Constitution of The American Legion Department of Ohio, That Article XII, Section 2, be amended to read as follows:

The amount of such annual Department dues beginning January 1, 2020, shall be twelve dollars (\$12.00) per member, of which each year at least one dollar and forty cents (\$1.40) shall be allocated to publish and mail to the entire membership a Department newspaper; at least twenty-five cents (\$0.25) shall be allocated for Department Convention operations; and at least thirty-five cents (\$0.35) shall be allocated to aid Delegates to the National Convention, and

BE IT FURTHER RESOLVED, That the Constitution of The American Legion Department of Ohio, Article X, Standing Committees, Section 2-a which reads:

There is hereby created a Department Reserve Fund for the purpose of aiding duly elected delegates, including the five (5) delegates at large under Article VIII, Section 5 of the Department Constitution, to attend the National Conventions of The American Legion.

The Finance Committee shall set aside annually thirty cents (\$0.30) of each member's dues for the purpose of establishing and maintaining this reserve fund and in addition said Finance Committee shall allocate to said fund such amounts as are determined by said Finance Committee to be needed to maintain said fund in a solvent condition from funds derived from any other activities which the Department may endorse, participate in, or promote which create surplus funds, all to be used in said Delegate Allowance Fund.

Each delegate to a National Convention, including the five (5) delegates at large, shall divide evenly an amount equal to the total membership multiplied by the thirty (\$0.30), the amount heretofore established for the purpose of aiding duly elected delegates to National Convention. For the purpose of obtaining the

total number of authorized delegates as well as establishing the membership criteria for the delegate allowance to be paid from, a delegate allowance shall be based upon the Department's membership current dues paid to the National Treasurer thirty (30) days prior to said National Convention. Rules for attendance to all National Convention business and caucus sessions shall be established by the Department Executive Committee. (Amended 82nd Department Convention 2000) Be amended to read as follows:

There is hereby created a Department Reserve Fund for the purpose of aiding duly elected delegates, including the five (5) delegates at large under Article VIII, Section 5 of the Department Constitution, to attend the National Conventions of The American Legion.

The Finance Committee shall set aside annually thirty-five cents (\$0.35) of each member's dues for the purpose of establishing and maintaining this reserve fund and in addition said Finance Committee shall allocate to said fund such amounts as are determined by said Finance Committee to be needed to maintain said fund in a solvent condition from funds derived from any other activities which the Department may endorse, participate in, or promote which create surplus funds, all to be used in said Delegate Allowance Fund. Each delegate to a National Convention, including the five (5) delegates at large, shall divide evenly an amount equal to the total membership multiplied by the thirty-five cents (\$0.35), the amount heretofore established for the purpose of aiding duly elected

delegates to National Convention. For the purpose of obtaining the total number of authorized delegates as well as establishing the membership criteria for the delegate allowance to be paid from, a delegate allowance shall be based upon the Department's membership current dues paid to the National Treasurer thirty (30) days prior to said National Convention. Rules for attendance to all National Convention business and caucus sessions shall be established by the Department Executive Committee.

RESOLUTION NO. 19-16

Subject: Constitutional Amendment: Add Section 1.A to article III, Membership

RESOLVED, By the American Legion Department of Ohio, assembled in general assembly at the Department of Ohio Convention assembled in Toledo, Ohio, June 28th -30th, 2019, That the Constitution of The American Legion Department, Article III, Section 1 which reads: Section 1. Any person shall be eligible for membership in The American Legion who was a member of the Army, Navy, Marine Corps, Coast Guard, or Air Force of the United States and assigned to active duty at some time during any of the following periods: April 6, 1917 to November 11, 1918; December 7, 1941 to December 31, 1946; June 25, 1950 to January 31, 1955; February 28, 1961 to May 7, 1975; August 24, 1982 to July 31, 1984; December 20, 1989 to January 31, 1990; August 2, 1990 to the cessation of hostilities as determined by the government of the United States, all dates inclusive, or who, being a citizen of the United States 2 at the time of his entry therein, served on active duty in the armed forces of any of the governments associated with the United States during any of said periods; provided, however, that such service shall have been terminated by honorable discharge or honorable separation, or continued honorably after any of said periods; provided further, that no person shall be entitled to membership who, being in such service during any of said periods, refused on conscientious, political or other grounds to subject himself to military discipline or unqualified service. Be amended to Section la to read: Section Ia. Eligibility requirements for membership in The American Legion shall be revised in accordance with The American Legion National Headquarters membership and eligibility requirements as stated in Article XV, Section 2.

RESOLUTION NO. 19-17

SUBJECT: By-Law Amendment: Modify Article II, Duties of Officers, Section 2A

Ohio Department Service Officers Report on Changes and Topics Learned in Washington D.C.

"The SitRep"

It has been a busy quarter for the Department Service Officers at the Cleveland VARO Office. There where 43 scheduled Board of Veterans Appeals hearing Scheduled. Decision Review Officer hearings scheduled were 19. A large portion of the BVA hearings where conducted by a travel board in which two Judges from the Department of Veterans Affairs in Washington D.C. made the trip to Cleveland to conduct the hearings face to face with the veterans. Currently to date the Department Service Officers has help veterans obtain \$4,910,234.10 in BVA Grants, \$1,212795.80 in DRO Grants and \$235,535.16 in Remanded Grants for a total of \$6,358,565.00 (date from February 2016 to present). Parting note Former Department Service Officer Adam Zaebst is no longer with the Cleveland VARO office. Veterans that where represented by Adam have been assigned to another DSO's in the Cleveland Office. DSO William Genochio attended Department Service Officer School in Washington D.C. and returned to the Cleveland VARO to inform fellow DSO's of the changes and topics learned.

Appeals Modernization Act The official launch of the Appeals Modernization Act (AMA) took effect February 19, 2019. What does this mean for our veterans now. The following guidance is provided to assist you in understanding the new rules and lanes available to veterans. But please feel free to call your Department Service Officers if there is any further questions or clarification needed. Rating Decisions prior to Feb-

ruary 19, 2019 the veteran can still file the 21-0958 Notice of Disagreement and stay in the Legacy Appeal process (this is the old system) or the veteran can opt in to the AMA process. Any rating Decision dated February 19, 2019 or later must select from three lanes in which to advance their appeal. Below are the three lanes in which the veteran can select: Supplemental Lane:

- · If you have additional evidence that supports, your claim. Evidence must be new and relevant to the claim for benefits.
- · This lane provides the VA's Duty to Assist meaning the VA will help gather evidence to support your claim.
- . The review of your claim will include any new and relevant evidence submitted since VA's last decision of the claim.
- · To file this claim use VA FORM 20-0995 (Decision Review Request: Supplemental Claim).

Higher-Level Review:

- · No new evidence is submitted, this triggers an entirely new review of the file as it is by a more experienced claims adjudicator.
- · Select if you have no new evidence and believe the information to grant the claim is already present in your file but was missed.
- · VA will not provide any Duty to Assist unless an error is found. The claim will then be returned to the decision maker to correct the error.
- · In this lane the veteran can request a one-time informal conference by phone to argue your claim. It is best to have the VA representative contact the Department Service Officer to argue on the veterans behalves.
- · To file this type of claim use VA FORM 20-0996 (Decision Review Request: Higher-Level Review)

Appeal to the Board Lane:

Under the Board lane there

are three lanes in which you can choose to send your appeal they are as follows:

- · Direct Lane: use if you do not wish to submit new evidence and do not want a Board hearing with a BVA Judge
- · Evidence Submission: Use if you have new evidence to support your claim again evidence must be new and relevant to the claim. No hearing is wanted, veteran wants decision based off the new evidence.
- · Hearing: use if you have new evidence to submit and want to have a hearing with a BVA Judge. You may submit evidence at the hearing of up to 90 days following the scheduled hearing.
- · To elect into on of these lanes, use VA FORM 10-182 (Decision Review Request: Notice of Disagreement).

If you disagree with a decision from the Supplemental Claim Lane, you may choose to resubmit the claim as another supplemental claim with new evidence, as a higher-level review or as an appeal to the Board of Veterans' Appeals. If you disagree with a decision from the Higher-Level Review Lane, you may choose to resubmit the claim as a supplemental claim or as an appeal to the Board of Veterans' Appeals. If you disagree with a Board decision you may either resubmit as a supplemental claim or through an appeal to the U.S. Court of Appeals for Veterans Claims

Under the AMA a veteran can also choose to select multiple lanes regarding your claim the following is an example:

Veteran filed claim for Service Connection for Hearing Loss, Back Condition and Mental Health condition. The veteran can divide up their claim and send each condition to a different lane. So, the veterans hearing showed loss of hearing on the exit exam with noticeable shift form the entrance exam. The veteran can send this to a higher-level review while sending the back issue to the Supplemental Lane after getting additional evidence to support the claims and appeal the Mental health to the Board lane.

Appeals Modernization Act might seem confusing but there appear to be benefits to the program that can assist the veteran. The notification letter is going to be more in depth and are supposed to outline the evidence used and the evidence needed to win the claim. The biggest take away is that if you have questions please call the American Legion Department Service Officer team for assistance. Blue Water Veterans and Agent Orange Update

There have been recent updates for Blue Water Navy personal and exposure to Agent Orange. The VA changed the M21-1 Manual for Disability Compensation to exclude all bays and harbors from presumption of exposure to herbicide agents.

38 U.S.C. §1116 refers to veterans who "served in Vietnam" the question is does this include service in the waters off Vietnam? The Federal Circuit stated yes it does "The intent of Congress is clear from its use of the term 'in the Republic of Vietnam,' which all available international law unambiguously confirms includes its territorial sea." Territorial seas extend up to "12 nautical miles" from the shore. This is further detailed in Procopio v. Wilkie, No. 2017-1821 (Fed. Cir. 2019) (Bergmann & Moore 2019).

The Department of Veterans Affairs has until April 29, 2019 to file an appeal to the decision made by the Federal Circuit. To date the VA has filed a stay of the decision while it decided to file a certiorari to the Supreme Court or not. This has placed all Blue Water claims at a temporary halt. Further insight even if the VA files the certiorari it is possible that the Supreme Court does not even look at the appeal due to only reviewing less than 100 cases per year. 

Eldest Living Department of Ohio Commander Reflects Time with The Legion

W. Dean Scholl, now 92 years old, dedicated a large part of his life to The American Legion. As the Bi-Centennial Department Commander, he has seen the American Legion change while many things have remained tradition. Department Adjutant, Suzette Heller sat down with Mr. Scholl and his wife Wanda, to conduct a buddy check, and gain insight from our eldest living Department Commander. During his tenure, he had the opportunity to meet President Ronald Reagan, among other important government officials.

W. Dean Scholl served in the US Coast Guard from 1945-1946. After being honorably discharged, he met the American Legion, who offered to assist him in completing his discharge paperwork which would result in him receiving \$300.00. He signed up to become a Legionnaire at a time when dues were just \$3.00 per year at Post 20 in Bremen, Ohio. Mrs. Scholl became a member of the American Legion Auxiliary, and despite their busy work schedules, she traveled with PDC Scholl almost everywhere. "The greatest part of my life was traveling with him (PDC Scholl) and meeting new people." said Mrs. Wanda Scholl.

PDC Scholl said that one of the best things about the Department of Ohio was the variety of people among each district. He stated that every district was different; Different people, with different goals and that is what made his travels so interesting. At the time he served as Department Commander, there was no such thing as a "Commander's Project."

PDC Scholl stated, that his focus was on our Department Programs and Membership which was around 140,000 members at the time. The Department also raised funds for Cancer Research and Treatment. If he had the choice to choose a project at the time, it would have been to support the School of the Blind, which trained service animals to support veterans and the blind.

When asked what his greatest memory was as Department Commander, PDC Scholl couldn't choose just one. He stated that meeting the Americanism and Government Test winners, and other children involved in our youth programs, was very impactful. "They were intelligent and mature-just like adults" he stated. He also recalls his memories of various trips to Past Department Commander and his wife

Washington DC. Attending the National Commander's banquet, in the US Capital was one of his fondest memories. "Senators, and other government officials were there, and the hospitality was great." he stated. As Bi-Centennial Department Commander, he had the honor of being present for The American Legion's "gift to the nation," where lighting for the Tomb of the Unknown Soldier was presented to the U.S. President and country.

Mr. Scholl also shared with us, his greatest mentors in The American Legion. PDC Alek Blair, Robert Ray, and Merle Brady were a few that made a great impression on him during his active time with the Legion. "They were great leaders and speakers he stated. They taught

me a lot and I picked up on a lot of things on my own." When asked what advice he would give our current Commander and staff, he stated the following: "To the Commander, try not to travel alone too much. Use good judgement when traveling and enjoying yourself. I took my wife with me everywhere and was a huge supporter of the Auxiliary. Also, be yourself. Remember that you were once a blue cap and will become a blue cap again. Just be yourself." 
