Stanley A. Pleasant was appointed to the high office of Commander by unanimous vote at the 99th Department Convention in July of this year. As Department Commander of the largest Veteran's organization statewide, Stanley will serve a 1-year term as the lead Ambassador of over 540 locations and 96,000 members.

Stanley graduated from Capital University with a Bachelor's of Arts (B.A.) degree in Business and Information Management, and is a graduate of The American Legion Extension Course Institute (ALEI). He has two daughters (Tiffanie and Tessa), five grandchildren and one great grandson. He resides in Dayton, Ohio.

#### **Service to Veterans**

Stanley has an impressive 22-year membership with The American Legion. He is a life member of the Chappie James Post 776. At National Level, he serves on the National Americanism Council. At Department level, he serves as the Current Commander, served as the 1st Vice Commander, 2nd Vice Commander, and Treasurer. At District level, he serviced as the Thundering 3rd District Commander, 1st Vice Commander, 2nd Vice Commander, Finance Officer, Judge Advocate, and Assistant Sergeant-at-Arms. At Post level, he served the Chappie James Post 776 as Post Commander for two terms, as Post 1st Vice Commander for three terms, as Post Adjutant for five terms, as Post Trustee for three terms, and as Post Historian. In addition, Stanley has served as Finance Committee Chairman, Child Welfare Committee Chairman, 2nd Vice Commander of the Montgomery County Council, and Buckeye Boys State Commissioner and

## 2017 Department Convention Highlights

The American Legion Department of Ohio conducted its 99th Annual Department Convention in Dayton, July 7th, 8th & 9th.

The three-day session of nearly 100,000 members of the Ohio American Legion was held at the Crowne Plaza, 33 East 5th Street, Dayton.

Highlights of the Convention included addresses by Officers and other dignitaries, the election and installation of the new 2017-2018 Officers and consideration of constitutional amendments and resolutions that involve Legion business and policies of state and national interest. Membership, VA & R, and Charities sessions were very well attended. The Dragons baseball game was delayed due to rain, but still had a very nice turnout of Legionnaires, Auxiliary and SAL members and their families.

The keynote speaker was Ronald "Jake" Clark, President and Founder of Save A Warrior, a non-profit organization dedicated to solving the epidemic of Veteran suicide. Jake is a US Army Vet-

eran of the Cold War era and the California Army National Guard during the Post 9/11 era. In between his military service, Jake worked for the Secret Service, the Los Angeles Police Department, and as a special agent for the Federal Bureau of Investigation. In 2012, as an MBA student at Pepperdine University, Jake interrupted his studies to create Save A Warrior in Malibu, California. The program takes timeless virtues - ideals like compassion, empathy, humility - and presents what is beautiful and good in a powerfully sacred experience. Save a Warrior focused on the whole person and all his/her many pieces with a goal of creating a "war detox" experience is to reduce pain and increase resiliency.

In addition to the guest speaker, various Department awards for the year were given out to those deserving Posts/individuals who have excelled throughout the year.

The American Legion Department of Ohio has embarked on an

NEW Membership Program, everything is new about this year's Program except an individual Legionnaire paying his or her dues online. The Department of Ohio is on a Test Program with National meaning that the Department of Ohio has a lot of input as to how this new Program will work, working out the bugs and making it user friendly. So, all of you also have an opportunity to give us feedback as to your experiences working with MyLegion.org with your Membership. We strongly encourage you to give us your feedback, send your feedback to legion@ohiolegion. com and on Subject Line label it as "Feedback MyLegion".

Legionnaires: To all of us legionnaires I ask that we all pay our dues as soon as possible. As all of you should be aware, your 2018 Membership Dues are due now, the first Dues Notices have been mailed. I highly recommend that you register with MyLegion.org and pay your dues online. This is the most convenient way, you do not have to mail anything, no postage stamps and depending on when you pay your dues it should stop future Dues Renewal Notices coming to you. You could still receive one

additional Dues Renewal Notice
IF your dues where not received
by National by their cutoff date.
We understand that there are many
people who do not use a computer.

2017 Dues: Some of you have not paid your 2017 dues as of this writing and we really need them paid now. By the Constitution and By-Laws of the Organization you are delinquent and no longer in good standing and it requires your Post to revote you back in as a member. This should not be a problem because your Post needs you as a member and the Department of Ohio and the National Organization needs you as a member, so please renew your 2017 and at the same time pay your 2018 dues and keep your continuous years of membership on going.

Exciting Changes Coming: We are looking at introducing some exciting changes to recognize each member over time and to thank you for your membership in The American Legion. We want all of you to know that you are not just a Membership ID Number to us, you are a veteran or military person who has served our Country honorably and earned your membership eligibility in the world's largest War Time Veterans Organization The American Legion. Thank You for your service. To help us recognize each of you as we implement these changes we would like for each you to send us by email at legion@ohiolegion.com or by U.S. Mail your Membership ID Number and your Date of Birth.

Post Officers: The 2017 Membership Year is not over until December 31, 2017, we still need to work on getting those members who have not paid their 2017 dues. They have been enjoying the benefits of being a paid-up member without paying their 2017 dues. We need to make some personal contact and ask them if there is a reason why they have elected to drop their membership and see if we can change their mind. We need them to understand that we are continually helping our veterans all over the world with getting their earned VA benefits and working feverishly to preserve those benefits for them and the veterans of the future such as their sons or daughters or grandsons or granddaughters. Even though they are delinquent we need to get them paid-up and reinstated as members in good standing. They have already been a member and we need to keep them as members. Please be sure to tell them about the other programs that The American Legion has that may help them in the future such as the National Emergency Fund if they were to be struck by a national disaster. About the scholarships that are available for possibly them or their children. WE NEED TO KEEP THEM AS MEMBERS. We can still get the Department of Ohio QUOTA for 2017 by getting the non-renewed members renewed.

In-fact this is the only way we can get the Department QUOTA, any new members now are for 2018. We know that many of the Quota

Post have several if not many members who have not paid their 2017 dues, but you made quota by getting new members. We desperately need these non-renewed members to pay their 2017 dues. Please help!

New Membership Program: As all of you should be aware the Department of Ohio is on the new MyLegion.org membership program that allows each Post to post your paid-up members directly to National. If you register your Post Bank Account directly with National the moneys will transfer automatically. There is NO checks to write, NO cards to mail and NO discrepancies as to how many members you have paid. If you have an issue with National and your Bank Account, you can always establish a separate account just for membership. Because Ohio is on this new Test Program each of you have an opportunity to make suggestions on improvements to how the program can be better, what reports that you would like to be able to generate. We encourage your input.

Awards Manual 2018: With your 2018 Membership Cards came two publications, the 2018 Membership Manual on how to process the membership cards and it should answer most of your questions, if not you can still call into Department and ask for any help that you many need. The second manual is the 2018 Membership Awards Manual. You really need to be familiar with the Awards schedule so that you can get your Post quali-

fied for the various Awards. There is monies to be won by making certain deadlines. The first one is September 6th and \$2000 is available to be shared by every Post that qualifies (\$2000.00 divided by however many Posts). There is another \$2000 for All-Time High Post. DON'T MISS OUT.

District Officers: We want to express to you how important it is to work with the County Officers and Post Officers to still work on the 2017 Membership. As indicated above the only way we can get the Department of Ohio QUOTA is to renew the 2017 members who have not renewed. We need your help we can get this done but it will take all of us to do so. Please Help.

2018 Awards Manual: Each District Officer needs to be totally familiar with the Awards Manual and help each Post to understand what is available out there for their Post to earn. There are District Awards also and all of you need to make sure that your District takes every opportunity to qualify for the District Awards.

To all please watch the ohiolegion.com website for more up-to-date information. Some changes are being made to bring it update the website and make it even more user friendly. After the changes are made I hope to keep you up-to-date with fresh information about membership as we progress through the year. One of my fellow Senior NCOs went missing last week. He was found yesterday. Suicide appears to be his cause of death. Thank you to my Legion members. I appreciate my extended family.

To my brothers and sisters who have served alongside me in the Armed Forces, the news of CSM Folsom's apparent suicide brings home the simple fact that we are on our own, just as in a

The VA cannot be there for us, forever paralyzed by bureaucracy. The military has spent untold amounts of resources trying to get us help, but still we are the ones facing the demons of wars fought. Society doesn't know what to think of us, nor are they trying. In fact, our society is the one that is failing to raise our young ones with the necessary coping skills, so when a person enters the stressful world of the military, we inherit a soldier who is often wholly unprepared to handle the stress. And in a basic training environment where we don't wash out the unfit and incapable, the Army fails to prevent the problem.

That leaves the service men and women and veterans only one crutch: each other. The world doesn't know us and the Government doesn't care. Join the

American Legion, IAVA, VFW, DAVA, doesn't matter who. JUST JOIN, BE ACTIVE, DO NOT LET YOURSELF BE ALONE.




After four days of baseball, the Napoleon River Bandits and the combined Beverly/Lowell teams made it to the final round. Due to the rules of double-elimination



## Veteran's Affairs & Rehabilitation Highlights

Veteran John P. was granted his 100% Service-Connection through the hope, help, and guidance of the staff and Department Service Officers in the Cleveland Office. He began his claim in 2002 and it was completed in 2017, resulting in 15 YEARS from start to finish! Mr. P expresses that the office kept telling him not to give up and had convinced him that he had a case worthy of waiting for.

Mr. P recommends that others use and recommend The American Legion to help navigate the VA system. As a result of the service provided to him he became a member of the organization and will most likely renew each year!

#### **VA&R HIGHLIGHTS!**

Veteran Jane Doe from Youngstown had recently called Department HQ in regards to her appeal that was filed in 2012 and died in 2016 because she moved and didn't have a forwarding address until November of 2016. In March of 2016 the VA mailed to the only known address of record for her, a decision within the appeal process that included a time sensitive document that needed to be returned to the VA within 60 days. This was never received by the veteran and was returned as "undeliverable" to the VA 30 days later.

She called because she was upset that the appeal died and she was under the impression that a former employee of ours had cancelled her case. I reviewed the case and explained to her the legal process of how this claim was cancelled and her options to "reopen" the case, which requires extensive "new and material" evidence. She was ok with that and says she was going to get the evidence needed and call me back.

In the meantime, I called our DSO team in the Cleveland Office and asked Adam, our newest DSO, to inquire to the appeals department in the VA Regional Office if they would be willing

to reopen the appeal, considering they received the returned piece of mail from the postal service within 30 days and there were no further attempts from the VA to locate the veteran. Later that afternoon I received a call from Adam saying that he inquired and they agreed! The appeal was reopened and they will send her the updated time sensitive document and allow her to submit in the proper time frame. If she files accordingly the original claim date of 2012 will not be lost. Thus, if she is granted the case in the appeal process she will receive retroactive monies to 2012.

It isn't just about the money or the disability. What we do for veterans is life changing and provides hope to folks who are up against a system that they may believe or perceive is working against them because they may not have the expert knowledge required to achieve a successful outcome. It is about providing a top notch service with an attitude that we will go above and beyond what any other organization is willing to do. This is the American Legion that I know and speak of. This is the mindset and the example of what we train our DSO's to do.

#### **KNOW THE LAW!**

VA&R Director, Suzette Price-Heller

What does it mean when the VA tells you that in order to "reopen" a previously denied claim that they require "new and material evidence"? This is what the 38 Code of Federal Regulations say: § 3.156 New and material evidence.

(a)General. A claimant may reopen a finally adjudicated claim by submitting new and material evidence. New evidence means existing evidence not previously submitted to agency decision makers. Material evidence means existing evidence that, by itself or when considered with previous evidence of record, relates to an

unestablished fact necessary to substantiate the **claim**. New and material evidence can be neither cumulative nor redundant of the evidence of record at the time of the last prior final denial of the **claim** sought to be reopened, and must raise a reasonable possibility of substantiating the **claim**.

In layman's terms, what they are saying is what is being submitted cannot repeat what the evidence at hand already says. New and material evidence could be evidence that already exists in the veterans claims folder but maybe it was not used as evidence in the decision and therefore never listed as evidence. These reasons are why it is important to look at the evidence on the rating decision that was used to make a decision and to sit with an accredited service officer who has access to the veterans claims folder so they too can review the evidence of record and draft a proper reopen or, a reconsideration if within the one year appeal time frame.

## Honor Flight • John Caipen • April 27, 2017

An Army Veteran, who served in Korea during the Korean War. He loves to tell war stories about his experiences during his time there. To listen to his tales is a Historical glimpse into the life of the person, away from home, in a fight for his country. He served from 1950 until 1952. John is a life member of the American Legion Portage Post 496 (Kent), and has served as its Chaplin forever. He has been Commander of this post and of District 14. He probably has held every position within the American Legion. He has been and still is a very active volunteer in the Veterans Administration Hospital in Brecksville, Ohio (now closed) and in Ravenna, Ohio. John completed his Army Basic Training, at Camp Breckenridge, Kentucky on November 30, 1950.

On November 10, 2011, John was one of twenty veterans inducted into the Ohio Veterans Hall of Fame, by Governor Kasich. To quote from the history of the Ohio Veterans Hall of Fame, "The Ohio Veterans Hall of Fame is not a military hall of fame. Those veterans selected for the honor of induction are veterans who have honorably served their country through military service and continue to

serve and inspire their fellow citizens with their deeds and accomplishments throughout their life time." This is quite an honor. After the ceremony the names of the inductees are displayed in the building that houses the offices of lawmakers serving in the Ohio House of Representatives.

The Honor Flight Network Program is a "No Cost" program that has operated out of Columbus, Ohio since 2005. It was founded by Earl Morse (retired Air Force, 1998) to provide veterans access to their memorial in Washington, D. C. When John learned about the Honor Flight he completed a Veteran Appli-

cation and submitted it.

After several weeks John was contacted by the Honor Flight that he was selected to go. He was advised that he would be assigned a "Guardian". A Guardian is a person who assists the Veteran during their trip. Johns' Guardian was Cheryl Link. She is pictured above with John and former Senator Bob Dole. Former Senator Bob Dole was part of the reception committee at Arlington Cemetery. This is a one day trip beginning at 5:30AM and ending at 9:15PM back in Columbus, Ohio, for the closing ceremony and a big welcome home party. John noted

that there were 300 people and a bag piper and High School Bands. John said that they were deluged with souvenirs, one being an embroidered flag. Everything from Columbus, Ohio to Arlington cemetery, Washington D.C. was with a police escort. John said that he "chocked-up" at the Korean memorial. They visited all the war memorials. He also mentioned that he saw Audie Murphy's grave site. While at the Korean Memorial, John met a young Korean family touring the memorial. John stated that it was a "remarkable experience, and he encourages everyone to take the trip".

Judge Richard E. Parrott, 83, of Marysville died unexpectedly Sunday morning, July 30th at OSU Wexner Hospitals in Columbus.






