

softball whenever I could. I've lived in Cincinnati for the past 12 years. I am a single mom to a son who is now 24 years old. My son served 4 years with the Ohio National Guard. This coming November I will be married to American Legion Post 630 Member and Navy Veteran, Greg Schroeder.

I was a member of the US Army and then the WV National Guard for several years. I signed on the dotted line in 1990 and shipped out for active duty training six months later in February 1991. I entered the service as a US Army Combat Medic. Most people have similar questions when they hear that you were a service member. The question usually contains two parts: one is "why" and the other is what made you do that? For me, it's complicated. I joined for two basic reasons. The first one is that my Grandfather was a Colonel in the US Army Medical Corp during the 1940's. Honorable reason, right? Well, the second reason is that my boyfriend at the time told me I would never succeed as a soldier (he was a former US Marine) and since I never back down from a challenge...I signed up. Once I was sworn in and began to learn more about the Army my primary reason changed. I was then a soldier for a better reason...I wanted to be a part of something much bigger than me. Becoming a Combat Medic was an amazing experience. I was trained and able to help ensure that injured soldiers would have a hell of a chance to make it home. Once you are a medic you learn that your motivation and outlook directly shapes someone's recovery. One of my training Sergeants told us that "as medics the soldiers in need call out for you before they call out for their mothers...take it seriously." That has stayed with me since 1991. During my time in I was assigned to the 2nd Armored Division in Northern Germany and also the National Training Center (NTC)

in the Mojave Desert in California. The NTC is the place where we prepare our soldiers and National Guard Members from all over the county for battle in a desert. My duty station was either an Emergency Room, Field Army Hospital, Ambulance, or UH-1 Helicopter. In summary, a lot of days weren't fun as medical situations don't always have a positive outcome but being a soldier and serving the country that I love is something that I will never regret. Being a soldier does something to you that you can't explain in words. Once you commit to give your life for your fellow soldier or for our flag, it changes you. I can't listen to the Star Spangled Banner without crying, still to this day. The pride in commitment and service never leaves vou.

JUDGE ADVOCATE

Our membership in The American Legion is an important valued part of our lives. For this reason, the National American Legion By-

Laws provide that: "Each post of the American Legion shall be the judge of its own membership," and "A post may suspend or expel a post member from The American Legion only after providing the

member due process and a proper showing of cause. Charges shall be based on disloyalty, neglect of duty, dishonesty and/or conduct unbecoming a member of The and American Legion. All charges must be made under oath, in writing by the accusers, and no member in good standing shall lose their membership until given a fair trial be the post or department in such manner or form as the post or department By-Laws and the Post or Department Executive Committee shall prescribe." The Department of Ohio has applied this same cri-

teria to the removal for cause of Post, District, County and Department Officers and has set forth the manner and form of procedure for trial in Article IV, Section 2 of the Department By-Laws. However, this section of the By-Laws provides insufficient guidance as to what due process is available to members and/or officers who are charged, as well as the procedure to be used at trial. For this reason, your Department Executive Committee has authorized the development of a draft Uniform Code for the Conduct of Disciplinary

Proceedings. This code will provide the details needed for posts to conduct fair trials, and will be adopted if the Department Convention authorizes the necessary change to the Department By-Law this summer. The code would then be included in a proposed new Department of Ohio Judge Advocates Manual which would be provided for each post.

Each post should have a Judge Advocate or an officer assigned the duties of the Judge Advocate who is familiar with the Post, District, Department and National

Constitution and Bylaws, Resolutions and other American Legion policy documents. The Judge Advocate need not be a licensed attorney. The Judge Advocate should also preside at any trial conducted by the post and should be a nonvoting member of the Post Executive Committee. Questions regarding the civil laws related to activities that are not official American Legion programs, such as charitable gaming and alcoholic beverage sales, as well as property ownership and taxation, should be referred to a licensed attorney.



An Excerpt from Ohio Department of Veterans Services Director

An Excerpt from Ohio Department of Veterans Services Director Deborah Ashenhurst Keynote Address given at the Mid-Winter Leadership and Membership Awards Banquet

Here are 7 steps to help recruit the next great generation of leadership at the American Legion. **Step 1: JUST ASK.** People like to volunteer. They feel good about themselves when they volunteer. So just announce why, when, and most importantly WHAT they can do. If you ask someone to do something specific, they will be a lot more likely to say yes, than if your invitation is an open one. It's easier to commit to doing one thing, on one day, than it is to just fill an open role.

And when you ask. DO IT IN PERSON. Not by phone, email or even worse text. When someone who is already volunteering their time looks you in the eye to ask for your help...it is hard to say no.

Step 2: TEAM. Remind them they are part of a TEAM. If they volunteer, they will be joining a team of volunteers working together to get the job done. Also ask your TEAMMATES for a list of individuals they feel work best with the Legion, and then ask those individuals to volunteer. Also ask your team what they like doing best for the American Legion. Focus on the positive and share those experiences and stories.

This being the 100th year is a great opportunity to ask them to

share their best memories and moments from their American Legion Experience. Then SHARE those stories. At meetings, on social media, in your newsletters, recruitment materials...in the grocery store checkout line. Get the word out about how great it is to volunteer at the American Legion. **Step 3: CREATE LIFETIME** VOLUNTEERS. Creating a relationship with new and old volunteers that will make then want to come back for more. When managing volunteers, treat them as if they are the best and most important part of your POST. If you feel valued and appreciated you are far more likely to volunteer again, and recommend to your friends, that THEY join in.

Step 4. NO IS NOT NEVER. Start recruiting volunteers as soon as possible. If you ask someone and they say no, don't take that as a rejection. Right now, might not be a good time for them. What you are asking this time might not be the right fit for them. But the next time their schedule might be better or the opportunity more desirable. Continue to stay in contact and make them aware of other opportunities down the road. Keep that door open, don't shut it just because they said no at this particular moment in their lives.

Step 5. LEAVE SEATS OPEN. It is critical that you screen volun-

teers to make sure that they are the "right fit" for the job. Sometimes a spot is better left empty than being filled with a person who is just there to fill a spot. The wrong person in the wrong spot can impact your post's ability to recruit the right person.

Step 6. PEOPLE DRIVEN. Recruit individuals who want to be part of your team and not just a say they are volunteers. Working together for the greater good pulls everyone up.

And finally, **Step 7. POSITION TITLE.** Individuals are looking at the title of a position as if were an employment opportunity. Provide as much detail as possible so that the volunteer knows what they are signing up for. Even "Retirees" like to be recognized with a named role.

I cannot tell you how many times having those two stars (that title) have opened a door for something that helps our veterans. Titles and stars aren't everything, but they can mean the right thing so keep them in mind when you are recruiting new talent.

Where can you get that new talent?

This year at ODVS we hired a storyteller in our communication department. His job is to find and tell great stories about our veterans. In doing so we have seen an increase in our social media traffic. Fresh new faces are joining, following and liking Veteran Services. Each one of those new people following us is a networking opportunity.

At the grassroots level, network-

ing in your communities with organizations whose members already volunteer in groups or individually is important. The Rotary, women's organizations, houses of worship, and college alumni associations are just a few of the kinds of groups that like to pitch in to make a difference.

Once you have that new talent, and new leadership, how do you transition allowing that new leadership to succeed spectacularly? Some studies have shown that two years after executive transitions, anywhere between 27 and 46 percent of them are regarded as failures or disappointments. That mean nearly a quarter to half of all transitions don't work.

One of the main reasons for lack of success is that new leaders get little help. They take on new roles and responsibilities without being prepared by the outgoing leadership. While many organizations supply new leaders with mentors or "buddies" less than 50 percent find them helpful.

Standard orientations can be even less effective. Why? Because they are not customized. But tailoring a coaching or succession plan can be tough, especially when you don't have a lot of resources to devote to them. So, let's go full circle here and look at those 5 five critical areas that could make you a top leader and get you into what Forbes magazine called the "Just 100".

First: What is your role as the leader? Take stock of your current

performance and capabilities. And then act and get everyone on the same page of your organization to work on your priorities.

Second: What is the culture? Is your post a well-oiled machine, everyone happily working together towards that common goal or do you need to shift things around?

Third: Your Team. Do you have the right team members with the right skills, attitudes and structure? Is everybody committed to becoming the best?

Fourth: YOU. Have you done whatever it takes to get up to speed and set expectations? Do you use your time wisely and efficiently by not doing too much or too little? Do you delegate to the right people?

And finally, **Fifth:** Think about your stakeholders. Do you understand what THEY need and are asking for? Have you delivered and therefore earned their trust?

That is a lot to take in. Being a good leader is hard work. But none of you would be here if you weren't willing to serve. You have already done that for your country and continue to do it for our veterans. The Ohio Department of Veterans Services is here to help you. Your brothers and sisters in arms are here to help you. Take advantage of the knowledge, resources and tools we all have to offer. DON'T hesitate to ask, for if we all work together, our job to help Ohio's veterans be all they can be, will be that much easier.

Department Law and Order Award District Nominations

Each year, The American Legion Department of Ohio gives public recognition to well-rounded public servants who have exceeded above and beyond the expected duties of their position at the annual Department Convention. Law Enforcement Officer of the Year, Firefighter of the Year, and Civilian Life Saver of the Year. All nominees must be citizens of the United States and are evaluated on community service, professional career, heroism, and supporting documentation (i.e. press articles, letters of recognition).

Nominees for the Law Enforcement of the Year Award must be a full-time and paid, sworn law enforcement officer entrusted with full authority and the powers of arrest. The officer also must be assigned to, or fully recognized by Municipal, County, District, State Police, Highway Patrol, Sheriff's office, or as a sworn Federal Law Enforcement Officer such as FBI, Secret Service Agent, United States Federal Marshal, National Park Police, Capital Police.

Nominees for the **Firefighter of the Year Award** must be an active, full-time paid, or certified volunteer firefighter who is also a member of municipal or county fire department. Emergency Medical Technicians, who serve in municipal or county fire departments are also eligible for this award.

Civilian Life Saver of the Year Award is to recognize any nonpaid or professional person who has saved a life.

American Legion Post is strongly encouraged to award qualified individuals at the local level. Nomination forms for Law and Order Awards are available on ohiolegion.com. The Department of Ohio has available to Post, at no charge, a Special Certificate of Recognition for presentation. These certificates may be requested anytime during the membership year. Local Posts are to send their nominations to their County or District leadership for consideration. Districts are required to set their own deadlines for Law and Order Award nominations. Districts may submit only one nomination per award category to Department Headquarters. District nominations are due no later

than Friday, April 3rd, 2020.

2. File out 21-22 for the surviving spouse. This form elects a Service Organization to represent the surviving spouse or claimant on behalf of the deceased veteran.

3. If the veteran has an existing claim or appeal with the VA, a 21P-0847 should be filed within one year of the veteran's death to allow the surviving spouse to continue the claim or appeal as if the veteran.

**There is a 1-year deadline to file to protect the effective date of the veteran's original claim or appeal.

4. The 21P-0847 can be filed after the 1-year, however the effective date of the request will be the date filed and not the date the veteran originally filed the claim or appeal. *What other forms need to be filed with the VA?*

1. 21-534EZ Application for DIC, Death Pension and/or Accrued Benefits.

2.21P-530 Application for Burial Benefits (this is automatic once the VA is notified of the veteran's death). If the veteran is not married or the spouse preceded the veteran in death. The VA will pay the burial benefits to whomever files first. (most funeral homes will assist in the filing of burial benefits)

3. Obtain the veterans Burial Flag with VA Form 27-2008. (most funeral homes will assist in obtaining the Burial Flags).

4. Apply for Presidential Memorial Certificate with VA Form 40-0247. (most funeral homes will assist in obtaining PMC).

Difference Between Dependent Indemnity Compensation and Death Pension

Dependency and Indemnity Compensation (DIC) is a tax free monetary benefit paid to eligible survivors of military Servicemembers who died in the line of duty or eligible survivors of Veterans whose death resulted from a service-related injury or disease.

The Survivors Pension benefit, which may also be referred to as Death Pension, is a tax-free monetary benefit payable to a lowincome, un-remarried surviving spouse and/or unmarried child(ren) of a deceased Veteran with wartime service. Addition information can be obtained by calling The American Legion Department of Ohio's, Department Service Officers at 216-522-3504 or by visiting the VA website via google search VA DIC or Death Pension.

Department of Ohio Temporary Financial Assistance Programs

The American Legion has two temporary financial assistance programs to offer to help families in need meet the cost of shelter and utilities.

Temporary Financial Assistance Grant is a single one-time non-repayable grant of up to \$1,500.00 for current members of The American Legion or an active-duty servicemember with minor children. This grant is provided by The American Legion Veterans & Children Foundation.

The Family Support Network Grant was established to provide temporary financial assistance to current members of The American Legion, members of the Ohio National Guard, the Ohio Air National Guard, and families of active-duty service members who reside in Ohio. This grant is a non-repayable grant of up to \$500.00. This program is made possible by your generous donations and Charities Inc.

Applicants must exhaust all local resources – to include the local county veterans service commission – before applying for The American Legion TFA programs.

We strongly encourage our post and districts to sponsor membership dues for a veteran who needs temporary financial assistance but is not a current member of The American Legion.

OHIO LEGION NEWS



The State of The Ohio General Assembly

January 14th, 2020

The 133rd Ohio General Assembly has proven to be very supportive of the veteran community thus far. The House and Senate Chambers will reconvene early February and is predicted to break for the summer and election season before Memorial Day weekend.

In 2019. Ohio enacted

Senate Bill 77 to designate June 12th as "Woman Veterans' Day".

Senate Bill 52 to create the civilian cyber security reserves forces

Senate Bill 7 which will allow for occupational license reciprocity for military families.

House Bill 18 to exempt disability severance payments to honorably discharged veterans from state income tax.

The State Operating Budget included measures that provided increased funding for the Ohio Veterans Homes and Veterans Service Organization including The American Legion Department of Ohio and established a

Transcranial Magnetic Stimulation (TMS) Pilot Program to help veterans who suffer from Post-Traumatic Stress Disorder (PTSD).

The 133rd Ohio General Assembly has much unfinished business to complete in 2020.

House Bill 282 which will permit the use of electronic instant bingo for charitable gaming continues to sit idle in the House Finance Committee while the debate regarding the differences between the House and Senate versions of the legislation to permit sports gaming overshadows HB 282. The American Legion Department of Ohio continues to collaborate with the Ohio Veteran and Fraternal Charitable Coalition (OVFCC) to lobby the state legislature to pass House Bill 282 before the crucial deadline in June.

Pending legislation that may benefit or impact members of the veteran community is as follows: House Bill 287 regarding Medicaid home and communitybased waiver services for rela-

tives of active-duty military. House Bill 359 will allow veterans of World War II to obtain World War II license plates without paying motor vehicle registration taxes and fees.

House Bill 406 will designate the "Honor and Remember" flag as the symbol of Ohio's commitment to honoring and remembering the lives of all fallen service members and them families. It will also require that the flag be displayed at the Statehouse on Memorial Day.

House Bill 411 will create the "Ohio Sons of The American Legion" license plate.

House Bill 437 and House Bill 439 seek to make adjust the Homestead Exemption for inflation and to permit the exemption for surviving spouses of servicemembers who die in the line of duty or whose death is otherwise service-connected.

Gifts for Yanks Program Update

The mission of the Gifts for Yanks Program is to improve the quality of life of the veteranpatient of Ohio VA Medical Centers and Ohio Veterans Homes by providing funds to support directservice programs, events, holiday gifts, and VA Voluntary services. The Gifts for Yanks Program is fully dependent on the financial donations and volunteer hours graciously given by members of our American Legion Family.

The Gifts for Yanks Program has entered the second-half of its' fundraising year and has just completed its annual holiday gift distribution. Legionnaires hand-

ed out just over 2,100 holiday gifts to veterans who are patients at Ohio VA Medical Centers and Ohio Veterans Homes. This years' holiday gift is valued at \$26.00 per veteran which included a medium-sized laptop backpack, a tumbler, a baseball cap, a pillbox, and a mind-puzzle book.

The Gifts for Yanks Program has raised \$68,558.30 with the support of 116 American Legion Posts. Contributions must be turned in by May 31, 2020 to be considered for Department Convention Post and District.

The Gifts for Yanks Program will recognize the (1) the largest post contribution, (2) the largest amount contributed by a district, (3) the greatest percent of fundraising goal achieved by a post, (4) the greatest percent of fundraising goal achieved by a district, and (5) post contributions of \$5,000.00 or more.

The post commander should issue a news release proclaiming April as Children & Youth Month and list what the post will be doing for its annual observance. (For a sample news release, see www.legion.org/youth.) Remember, programs affecting the children and youth of your community are news! Invite the news media to your activities and keep them informed.

dren and youth by your post/unit during the current year, as well as the number of children who received services and assistance. Shortly after the first of the year, American Legion departments receive copies of the Consolidated Post Report (CPR) for later distribution to posts. This form has been developed to track necessary information about the Legion's overall program. It is the responsibility of the post Children & Youth chairman to report his/her program activities to the individual designated in the post to complete the Consolidated Post Report. The CPR can be done online at myLegion.org by the post adjutant.

DARELL BISHOP THANKS THE STUDENTS OF WHITMER HIGH

In your lifetime, could you find a young group of men and women who believed in the values of The American Legion and honor the sacrifices that our veterans have made? Two year ago, I had the opportunity to meet such a group - a social studies class from Whitmer High School from the Toledo metropolitan area who have remained dedicated in their support of an American Legion program.

Since 2002, social studies class from Whitmer High has collected money for the Gifts for Yanks program.

High school students, voluntarily gathered up their nickels, dimes, whatever they could afford, to collectively save it in a class glass jar.

This initiative has become quite a competition between Social Studies classes from one year to the next to see which class can raise the most money for the Gifts for Yanks program.

AMERICANISM The Fifth Man of the Four Chaplains

At Mid-Winter Conference, I introduced a fifth man to the Four Chaplains ceremony. Many asked about him so I thought that for Black History month (February), I would introduce you to him.

I had been doing a lot of research over the years and I came upon Stewards-Mate First Class Charles Walter David, Jr. He was a young black man who served aboard CGC Comanche on North Atlantic convoy duty during World War II. The Comanche was on scene with the Dorchester and its crew searched for survivors in the North Atlantic waters. David fearlessly volunteered to dive overboard to help rescue the Dorchester's crew.

As other Comanche crew members volunteered to dive in, 93 survivors from the Dorchester were rescued and plucked out of freezing waters. One of the men David saved was a fellow Comanche crewman, the cutter's executive officer who had fallen overboard and after exhaustion set in he was unable to pull himself out of the water. David was able to tie a line around him and the crew aboard Comanche hoisted him to safety.

After the last of the survivors were safely aboard Comanche, David began to climb the cargo net to the ship's deck. One of David's shipmates, who had volunteered to dive overboard to assist with the rescue, was having trouble climbing the net due to his freezing limbs. David encouraged his friend to continue but the man was fatigued and frozen. David descended the net and with the help of another crew member, pulled him to Comanche's deck.

Tragically, David died a few days later from pneumonia that he contracted during his heroic efforts to save the Dorchester's survivors and members from his own crew. He was posthumously awarded the Navy and Marine Corps Medal for his bravery, which was received by his wife and son.

David served his country at a time when the service was segregated and was aboard a cutter where he was barred from the officer ranks and limited in his enlisted specialty. Despite this, David exercised the Coast Guard's core values of honor, respect and devotion to duty to the highest measure.

During this annual observance, we should all reflect upon what it means to be an American and rededicate ourselves and our posts to taking action that will uphold the principle of "a 100 percent Americanism." Americanism, one of the Legion's four pillars, is the love of America, loyalty to its ideals and institutions, allegiance to its flag, willingness to defend it against all enemies, foreign and domestic, and a desire to advance the blessings of liberty to future generations.

The legacy of Americanism is a legacy worth preserving, not only to honor those men and women who have served and laid down their lives to secure our freedom, but to ensure that our freedoms and way of life are secure for generations to come. During Americanism Month, let us rededicate ourselves to a 100 percent Americanism for 100 percent of the year!

Since it is Americanism month, we will highlight our Americanism programs as well as reflecting upon what it means to be an American and rededicate ourselves and our posts to taking action that will uphold the principle of "a 100 percent Americanism".

Americanism and Government Test and Trip - The Americanism and Government Test program of

the Ohio American Legion was created by Legionnaires of Ohio in 1936 and remains today as another of the leading youth programs of the Ohio American Legion. Although created by the Ohio American Legion, the Americanism and Government Test program is a joint venture and partnership with the Ohio American Legion Auxiliary, which is a cosponsor of the program.

The Americanism and Government Test program is open to students in grades 10, 11, and 12. Students in grade 9 may take the test for practice only. It is designed to test an individual student's knowledge of the following: The United States Flag, The Declaration of Independence, The United States Constitution, State government in Ohio, County government in Ohio, City government in Ohio, Township government in Ohio, Village government in Ohio, and School District government in Ohio. The State Award from the Ohio American Legion for the 18 State winners is a five (5) day, all expenses paid trip to Gettysburg, Pennsylvania and Washington D.C. under the direction of the Department Americanism Coordinator, accompanied by representatives of the Ohio American Legion and Ohio American Legion Auxiliary. A highlight of the trip is a

Wreath Laying at the Tomb of the Unknowns at Arlington National Cemetery.

The Ohio American Legion and Ohio American Legion Auxiliary have had the honor of laying a wreath at the Tomb of the Un-

knowns every year since 1936.

An objective of the Ohio American Legion through the Americanism and Government test program is that if by taking the test a young person is inspired to learn more about government, the United States, and to appreciate the freedoms enjoyed by the nation's citizens, the effort put forth by the Ohio American Legion and the Ohio American Legion Auxiliary is worth the expense.

Buckeye Boys State - The American Legion Buckeye Boys State program is an eight (8) day "handson" experience in the operation of the city, county, and state levels of Ohio government, the organization of Ohio political parties, and the relationship of one to the other for young men coming out of their Junior year of high school.

Mission Statement - The mission of The American Legion Buckeye Boys State is to provide an educational and leadership program that exposes young men to the rights and privileges, the duties and responsibilities, and the love for God and Country necessary to being self-governing citizens.

Vision Statement- Through a practical, objective, nonpartisan approach, participants in the American Legion Buckeye Boys State program are exposed to fundamental democratic principles in local, county and state elections and governmental functions which prepare them for leadership roles as patriotic American citizens.

Oratorical Contest - High school students in Ohio, including home schooled, are afforded the opportunity to gain financial awards to assist the students in their pursuit of higher education through participation in The American Legion High School Oratorical Scholarship program, a public speaking contest on the United States Constitution which focuses on the duties and obligations of a citizen to our government. The contest has a prepared oration and an assigned topic which is assigned the day of the contest. The prepared oration must be on some aspect of the Constitution, with emphasis on a citizen's duties and obligations to our government. The same subject and oration used in the department contest must be used in the national contest. The purpose of the assigned topic discourse is to test the speaker's knowledge of the subject, the extent of his or her research, and the ability to discuss the topic as related to the basic principles of government under the Constitution.

Dayton National Cemetery & Western Reserve National Cemetery - On the Saturday prior to Memorial Day, the Department of Ohio conducts this program which involves Dayton, Rittman, Medina, and the surrounding area Venture Scouts, Boy Scouts, Cub Scouts, Girl Scouts, Brownie Units, The American Legion Auxiliary, Sons of The American Legion, and Legionnaires.

Scout representatives place American flags at the headstones of almost 90,000 graves.

The American Legion sponsors the "Avenue of Flags": 425 flag poles bearing the casket flags

of deceased veterans, which are flown on Memorial Day and Veteran's Day.

Scouting programs - There are 135 American Legion Chartered Scouting Units in the Department of Ohio with over 2,600 participants.

The Department presents the "Department Eagle Scout of the Year" award annually. The Department winner advances into the National American Legion competition and receives a \$500.00 financial award from the estate of Mikeal and Frances Golato.

Educator of the Year - The Department of Ohio recognizes outstanding Ohio educators at the State Convention annually for contributions made to the field of education, Ohio students, and the Department of Ohio American Legion. The "Educator of the Year" is selected from 14 district educator nominees.

American Legion Baseball -American Legion Baseball is the finest summer baseball program for high school students in Ohio and the nation today. American Legion Baseball serves as the largest source of talent to major league teams of any youth baseball program. In 2019, over 55% of all players on 30 major league team rosters played American Legion Baseball. 2020 marks the 95th year for American Legion Baseball, an enviable anniversary in any field. For these past 94 years American Legion Baseball has strived to maintain the reputation as the highest regarded youth baseball program in the nation.






