3. Approval of previous minutes

4. Legislator of the Year Criteria
Discussion was had about editing the Legislator of the Year award criteria.

1. Eligibility Criteria:

• Must be a current member of the United States Congress or the State of Ohio General Assembly or was a member of the United States Congress or Ohio General Assembly at the time of application.

2. Alignment with American Legion Preamble Principles:

- Demonstrated commitment to Americanism, including promoting patriotism and responsible citizenship.
- Efforts to maintain a strong national defense.

- Dedication to the rehabilitation and care of all veterans.
- Active in programs that benefit the youth of America.
- Commitment to fostering a sense of community and mutual support among citizens.

3. Legislative Achievements:

• Sponsored or co-sponsored legislation that significantly benefits veterans, military personnel, and/or their families. Which supports American values, freedom, and democracy.

4. Community Impact:

• Evidence of positive impact on local communities, especially in areas that resonate with the American Legion's mission and programs.

5. Nomination Process:

- Nominations can be made by American Legion posts through their Districts then submitted to the Department Legislative Commission for review.
- A detailed submission outlining the nominee's qualifications and contributions, with specific examples, is required. *i.e.* suggested, 1-2 pages

6. Selection Criteria:

- The Legislative Commission will select from the nominations one (1) Member of Congress and one (1) member of the Ohio General Assembly.
- The selection will be based on the extent to which the nominee's actions reflect the American Legion's preamble and overall impact.
- The Legislative Commission will make this recommendation to the Department Executive Committee each year at the December meeting for presentation in the following year.

7. Award Presentation:

- The award for a member of Congress will be presented in Washington D.C., during the Washington Conference.
- The award for the Legislator of the Ohio General Assembly will be presented at the Ohio State House.
- Should neither of the above locations be an option, the awards may be presented to either recipient within their District or at an American Legion Department of Ohio Convention or Conference.
- The presentation might include a plaque or certificate, along with a press release to local and national media, the Ohio Legion News, and video if appropriate, to ensure appropriate recognition.

8. Additional Considerations:

- The award should be non-partisan, focusing solely on the achievements and impact related to the American Legion's values.
- Consider establishing a recurring schedule for the award, such as annual, to maintain its prestige and relevance.

This framework aims to ensure that the award is meaningful, aligning closely with the values and objectives of the American Legion while honoring significant legislative contributions.

5. Dave Joyce Proclamation- Commission would like the proclamation to be sent to their office and they can add or remove things they see fit as a courtesy.

Congressman David Joyce has been actively involved in supporting veterans, Americanism, children and youth, and national defense through various initiatives and legislative actions:

1. Support for Veterans:

- Congressman Joyce introduced the Solid Start Act, which was signed into law. This law makes permanent a program that contacts every veteran three times by phone in the first year after they leave active duty to connect them with the U.S. Department of Veterans Affairs programs and benefits. The program prioritizes outreach to veterans who accessed mental health resources prior to separation, aiming to quickly connect at-risk veterans to services.
- He introduced a resolution designating September 30th as National Veterans Suicide Awareness and Prevention Day, emphasizing the importance of supporting veterans' mental health and suicide prevention efforts.
- Joyce supported the passage of the PACT Act, which expands healthcare benefits to millions of veterans exposed to toxic burn pits during military service.

2. National Defense and Military Families:

• He introduced the Military Family Violence Prevention Act, aiming to improve the Department of Defense's Family Advocacy Program. This bill focuses on resourcing, improving coordination on military installations, and increasing education about the program to prevent domestic violence and abuse in the military.

3. Children and Youth:

• Joyce, along with Congresswoman Ann Kuster, introduced a resolution to recognize April as National Child Abuse Prevention Month. This initiative is part of their work as Co-Chairs of the Bipartisan Task Force to End Sexual Violence, focusing on raising awareness for child abuse, educating on signs of abuse, and promoting ways to help in communities.

4. Americanism:

• While there is no specific legislation directly mentioning Americanism, Joyce's actions, such as supporting veterans, addressing child abuse, and preventing violence in military families, reflect values aligned with Americanism. These actions demonstrate a commitment to protecting the rights and welfare of American citizens, including those who have served the country and the younger generation.

These contributions show Congressman Joyce's dedication to issues critical to veterans, the military, children, youth, and overall national well-being, reflecting principles that are often associated with Americanism.
