Ty Bowers, 5<sup>th</sup> District Chairman asked the Commission if there is a set of guidelines the District has in case of emergencies or if the Posts need to have them from the ground up. Discussion was had that it is important for the Districts to talk to their Posts about what the Posts can do following a natural disaster instead of waiting for the District to tell them what to do. At the next in person meeting, the Commission will create suggested guidelines for in Posts and Districts following a natural disaster.

Discussion was had about HAM radio operations during natural disasters. Christie White, Department Coordinator will reach out to the former coordinator and National Headquarters to see if a local HAM radio operator can attend the next meeting and discuss with the Commission the importance of HAM radios and their use after a natural disaster.
