SUBJECT: To Exercise Article V Section I of The American Legion Department of Ohio Constitution

REFERRED TO COMMITTEE ON: Department Executive Committee

WHEREAS, The American Legion Department of Ohio Constitution, Article V Section 1 requires the Department of Ohio Convention to be held annually; and

WHEREAS, On April 9, 2020, The American Legion Nation Executive Committee (NEC) adopted National Resolution No. 3, which cancelled the 2020 National Convention due to the worldwide coronavirus pandemic, also known as COVID-19; and

WHEREAS, National Resolution No. 3, adopted by The American Legion National Executive Committee strongly urges that all American Legion department follow a similar course of action; and

WHEREAS, The President of the United States, on account of the COVID-19 pandemic, has declared a National Disaster; and

WHEREAS, The Governor of the State of Ohio declared in Executive Order #2020-01D on March 9<sup>th</sup>, 2020, that the state of Ohio is in a public health emergency as a result of COVID-19; and

WHEREAS, The Director of Ohio Department of Health issued a "Stay At Home Order" for all persons in Ohio unless they are engaged in essential work or activity as defined in the order and it also prevents mass gatherings defined as ten (10) or more persons; and

WHEREAS, In Article V, Section 1, Paragraph II of the Department Constitution it states that "In the event that it becomes impossible or impracticable to hold a Department Convention in the City selected by previous conventions, the Department Executive Committee may change the site and time of any Convention by a three-fourths vote of the said Department Executive Committee, if conditions necessitate, said vote may be taken by electronic communication (telephone, email, fax)"; and

WHEREAS, A physical gathering of the members of The American Legion at the Department Convention would be in conflict with the restrictions set forth by local, state and federal authorities and therefore place our members at an unnecessary health, safety and medical risk; and, now, therefore be it

RESOLVED, That The American Legion Department of Ohio Executive Committee by a three-fourths vote in emergency session by electronic video conference on April 15<sup>th</sup>, 2020, finds that it is impossible and impractical to schedule a 2020 Department Convention on a date certain and hereby postpones said convention until a date to be determined, upon the lifting of the governmental restrictions on the size of gatherings and a finding by the Department Executive Committee that convening such convention would not pose an undue risk to the health and safety of those persons attending said convention.
