Adjutant's Report

New Detachment Officers Elected. Congratulations to Ohio's new officers for 2023-2024: Dave Dilts, Commander; Tim Conway, First Vice-Commander; Jeff Vrabel, Jr., Second Vice Commander; and Todd Bidlack, Chaplain.

New Officer Certifications & Old Membership Cards. As I write this, we have received 2024 Officers Certification Forms from 188 of our 319 squadrons, for 58.93%. Our Detachment Constitution sets the reporting deadline as May 1, so if yours isn't one of the 188 then you're late and we need you to submit your report immediately — this is one-third of the requirement to receive your new 2024 membership cards. Department cannot update our contact lists without the new officer details — even if you have no changes to report.

The reporting form is available in multiple formats from the SAL section of the department website at https://ohiolegion.com/sal/.

DO NOT RETURN YOUR OLD 2023 CARDS TO HQ – they don't want them back!

Annual Squadron Data Report. With the activation of online renewals as an option for individual Sons members, it is more important now that all squadrons submit the Annual Squadron Data Report to the detachment by April 15 each year. This allows time for department staff to transmit them by May 1. (Yes, we are already many weeks past that target!)

At this time, we have 181 of the 319 reports submitted. If you haven't filed yours, please obtain a copy from the state website and get it sent in. This form MUST BE FILED EVERY YEAR, even if the information has not changed.

If you have not filed this report already, I made an executive decision this Spring to have national

charge your members a rate of \$25.00 (the Ohio squadron average). If any of your members contact you asking why they're being charged more or less, you can tell them it's because you haven't submitted the proper form to set the amount correctly.

2023 Consolidated Squadron Reports. Your 2022-2023 Consolidated Squadron (and District) Reports are also due to Department Headquarters by May 1. We have received 161 so far for 50.47% but can and need to do better. We them to be filed by July 1st at the latest in order to ship your 2024 cards in the first batch of deliveries – assuming your officers are certified and your SDR is filed! Please get yours in so we don't have to hound you about it.

The current form is also available from the Department website.

The American Legion uses the data provided on the reports to help demonstrate to the U.S. Congress just how much we do in support of our nation's veterans and children when the national commander appears before it. Please submit the CSR form as soon as you can, even if you only update your membership data at the top, and make sure to use your paid membership counts for this year and last — not "2023" and "2022" — and DON'T LEAVE THEM BLANK, EITHER.

Summer DEC Meeting – July 22, 2023. The Detachment Executive Committee will meet at 10:00 am at Department Headquarters, 60 Big Run Rd., Delaware, Ohio 43015. All elected and appointed Detachment Officers, Commission and Committee Chairmen, District Commanders, and District First Vice Commanders are required to attend. Among other business we will approve the final slate of delegates, alternates, and guests for the National Convention.

I would ask everyone who will be giving a report at the DEC meeting to file a copy with me (electronically, if possible) to facilitate the preparation of the minutes in a timely fashion. This really makes things much easier.

2023 National Convention – August 25-27. The 51st National Convention of the Sons of The American Legion will be held in Charlotte, North Carolina. All members listed and approved as delegates at the Detachment Convention should have received housing reservation forms by now. It is also available on the OhioLegion.com website. Please make note of the registration deadline: July 3. This is not a postmark date. Any registrations not

received at Department Headquarters by that date will not be delegates. You must make your reservation through Department Headquarters.

When making your travel plans, please keep in mind that the opening session of the convention is at 1:00 pm EDT on Friday, and the installation of officers is on Sunday after noon. All delegates are required to attend all the convention sessions unless specifically excused by the delegation chairman, Dennis Albright. Any absences will be reflected in a reduced stipend after the convention. Dual members attending Legion meetings will be excused from the SAL sessions but are not entitled to a reimbursement share for those sessions.

If you have any questions about the Charlotte convention, please contact me or Department SAL Liaison John Robinson and we will get them answered for you.



Constitution & Bylaws Review

Each Squadron and District should have a copy of their Constitution and Bylaws available at all meetings for reference. Both should be reviewed for discrepancies and updates every 5 years. If you don't remember when yours was done, it's possibly due.

Both The Department of Ohio and The National Sons of The American Legion's Constitution and Bylaws have been revised, and their review brought several suggested amendments to the Detachment of Ohio Constitution. Some were just housekeeping issues, and others were to bring Ohio SAL in line with Department and National. One major thing that must be recognized is that a Squadron must submit

membership either online or by mail within 30 days of a member paying.

In a show of the democratic process Delegates voted down a proposed amendment to change the Detachment Chaplain to be an appointed position. Other changes include that there is now a clear procedure for discipline to be followed. The amended Constitution and Bylaws will be on the detachment web site soon.

The American Legion Child Welfare Foundation (CWF) grant application for 2024 is online at cwf-inc.org. To be considered for a CWF grant, applications must be received at American Legion National

Headquarters in Indianapolis no later than July 15, 2023.

CWF accepts funding proposals from nonprofits for projects that contribute to the physical, mental, emotional, and spiritual welfare of children. Grants are only given to entities that help U.S. children in a large geographic area; they are not awarded for day-to-day or special operating expenses.

In May, the American Legion Child Welfare Foundation <u>awarded 17 grants to 16 nonprofits</u> totaling \$797,251. These grants are made possible through donations to CWF.

For example, Sons of The American Legion Squadron 347 in Lady Lake, Fla., held a fundraising golf

tournament on May 13 and raised \$20,000 for the Child Welfare Foundation. "Over 130 golfers and many volunteers got together at Harbor Hills Country Club to have a fun day of fellowship, friendly competition and fundraising," wrote Doug White, Squadron 347 historian, on Legiontown.

The Fiscal Responsibility Act (FRA). Passed veterans receive special protection in this agreement. Medical spending by the Department of Veterans Affairs is not reduced and the Department's pandemicera appropriation are not rescinded. Veterans are also exempt from work requirements in the SNAP (food stamp) and TANF (general social safety net) programs.

Jonathan Edward Morgan, age 68, of Norwalk, passed away peacefully Saturday, May 20, 2023, at his residence surrounded by his family.


