9. New Business: Discussion Truelieve medical marijuana Company. Heller asked what they are asking of the American Legion, vague or what they want. They have 7 locations in Ohio. Will need to check to see. Perry asked for a budget, they did get new coffee maker, to replace old one. He noted the SAL took vets on a trip. Genochio reported that Troy Elliott and he attended a Suicide Prevention at the Chillicothe VAMC last week. Had a great turnout at the event.

Update on Various Bills: These Bill have all been introduced into the 2025-2026 119<sup>th</sup> Congress.

i. H.R.71 Health Care Freedom Act: (Introduced House – Veterans Affairs) (2/6/2025 refereed to Subcommittee on Health) Department of Veterans Affairs (VA) to implement a three-year pilot program to improve the ability of veterans who are enrolled in the VA health care system to access hospital care, medical services, and extended care services through the covered care system by providing such veterans with the ability to choose health care providers. Under the bill, the covered care system includes VA medical facilities, health care providers participating in the Veterans Community Care Program

(VCCP), and eligible entities or providers that have entered into a Veterans Care Agreement.

- ii. H.R.333: Disabled Veterans Tax Termination Act: (2/11/2025 referred to the Subcommittee on Disability Assistance and Memorial Affairs)) This bill modifies provisions related to military retired pay. Specifically, the bill authorizes veterans with a service-connected disability of less than 50% to concurrently receive both retired pay and disability compensation. The bill also makes qualified disability retirees with less than 20 years of retirement-creditable service eligible for concurrent receipt, subject to specified reductions in retired pay.
- iii. H.R. 303 Retired Pay Restoration Act: (2/11/2025 referred to Subcommittee on Disability Assistance and Memorial Affairs) This bill allows the receipt of both retired military pay and veterans' disability compensation with respect to any service-connected disability. Under current law, only individuals with service-connected disabilities rated at 50% or more receive both without offset.
  - Individuals who were retired or separated after at least 20 years of military service due to a service-connected disability shall be eligible for the full concurrent receipt of both veterans' disability compensation and either military retired pay or combat-related special pay.
- iv. **H.R.2164:** (3/14/2025 referred to House Committee on Veterans Affairs) This bill requires the Department of Veterans Affairs (VA) to begin the process of entering into an agreement with the Montgomery County Land Bank not later than 30 days after the date on which the land bank makes an offer to transfer at no cost a specified parcel of land in Dayton, Ohio, to the VA to expand the Dayton National Cemetery.
- v. **H.R.2102 Major Richard Star Act**: (04/04/2025 referred to Subcommittee on Disability Assistance and Memorial Affairs) To amend title 10, United States Code, to provide for concurrent receipt of veterans' disability compensation and retired pay for disability retirees with combat-related disabilities, and for other purposes.
